Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 1115 states the Legislature's intent to appropriate \$200,000 to the Power Review Board from cash funds for a study of state, regional, and national transmission infrastructure and policy for future needs.

The Power Review Board assumes that the \$200,000 appropriation would be used to hire consultants. Beyond that cost, the PRB estimates \$2,000 for related travel expenses for the working group identified in section 4 of the bill. This estimate appears to be reasonable.

COMMENTS: LB1115 contains intent language for an appropriation of \$200,000 in cash funds to the Nebraska Power					
Review Board. The Nebraska Power Review Board shows the expenditure on their fiscal note as General Funds. I believe					
the intent is that this expenditure should be on the cash fund line. Cash fund revenue would be generated by the fee					
assessed to power companies based on actual appropriation made as a result of passage of LB1115. The report is					
due December 15, 2014 and the bill contains the emergency clause. The Nebraska Power Review Board does not appear to					
make an estimate of an hourly cost for the consultant or the hours needed to produce the report by the due date.

**Explanation of Estimate:** 

LB 1115 assigns the Power Review Board the responsibility to issue a request for proposals to retain the services of a consultant to coordinate the activities of a working group that would study the transmission issues set out in the bill. The bill does not specify whether the Board members would be responsible for hiring the consultant or directly participate in the hiring process, or if the members of the working group would perform that task. For purposes of this fiscal note, the Board assumes that the Board members would handle or participate in the hiring of the consultant. If the Board's executive director and general counsel participates in the process to hire the consultant and then in the working group's activities, the Board believes those travel costs and incidental expenses could be absorbed by the agency's current budget. If the Board members would be entitled to per diem payments, which must come out of the agency's personal services limitation. In that case, the Board would need additional funding for the per diems. The Board also assumes that the per diems would not be taken out of the \$200,000 allocated for hiring the consultant and related expenses.

Power Review Board members receive \$60 per diem for each day they are engaged in official activities related to their capacity as Board members. If all five Board members were to review the Request for Proposals, participate in responding to questions submitted by potential applicants, review resumes and applications submitted for the consultant position, participate in interviews, attend the first meeting of the working group, and approve the study prior to presentation to the Legislature's Executive Board, the Board estimates it could potentially incur up to \$2,000 in per diem expenses.
