Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 339 would amend sections of law relating to fence disputes. LB 339 would eliminate provisions referring parties in a fence dispute to the Department of Agriculture farm mediation program or the Office of Dispute Resolution, and would instead direct the county court to issue an order to three disinterested householders of the county to serve as fence viewers. The fence viewers would be required to make a report under oath regarding their determination. Unless the landowners disputed the determination, the court would accept the report as judgment in the action.

Because the fence viewers would be paid \$35 per day or portion thereof and be reimbursed for mileage, there would be costs related to the appointment of viewers, but costs are not expected to be significant. There may be slight workload decline in the farm mediation program and the Office of Dispute Resolution.
