Explanation of Estimate:

LB 667 provides an exception for motorcycles to certain vehicle light requirements. Under Section 1, Section 60-6,229, it is currently unlawful for any person to drive or move any vehicle upon a highway with any red or green light visible from the front with the exception of law enforcement, fire departments and school buses. This section would not apply to lights on a motorcycle that are decorative light-emitting diodes.
