Explanation of Estimate: LB 951 would provide that releases filed with the Workers Compensation Court for lump-sum settlements that do not require approval by the court shall be final and conclusive unless procured by fraud. Additionally, the amount to be paid shall be paid within thirty days after the date of filing and if not, a fifty percent assessment will be added to the amount due. Finally, the release pursuant to LB 951 shall be a full and complete discharge from further liability for the employer and the court shall enter an order dismissing the action with prejudice.

There is no anticipated fiscal impact for LB 951 to the State because our current contract with our third party administrator requires any penalty fees assessed are the responsibility of the third party administrator.
