# A BILL

- FOR AN ACT relating to community colleges; to amend section 85-1511,
  Revised Statutes Cumulative Supplement, 2012; to change a
  date relating to a comprehensive audit; and to repeal the
  original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 85-1511, Revised Statutes Cumulative

- 2 Supplement, 2012, is amended to read:
- 3 85-1511 In addition to any other powers and duties
- 4 imposed upon the community college system or its areas, campuses, or
- 5 boards by the Community College Aid Act, sections 85-917 to 85-966
- 6 and 85-1501 to 85-1540, and any other provision of law, each board
- 7 shall:
- 8 (1) Have general supervision, control, and operation of
- 9 each community college within its jurisdiction;
- 10 (2) Subject to coordination by the Coordinating
- 11 Commission for Postsecondary Education as prescribed in the
- 12 Coordinating Commission for Postsecondary Education Act, develop and
- 13 offer programs of applied technology education, academic transfer
- 14 programs, academic support courses, and such other programs and
- 15 courses as the needs of the community college area served may
- 16 require. The board shall avoid unnecessary duplication of existing
- 17 programs and courses in meeting the needs of the students and the
- 18 community college area;
- 19 (3) Employ, for a period to be fixed by the board,
- 20 executive officers, members of the faculty, and such other
- 21 administrative officers and employees as may be necessary or
- 22 appropriate and fix their salaries and duties;
- 23 (4) Subject to coordination by the Coordinating
- 24 Commission for Postsecondary Education as prescribed in the
- 25 Coordinating Commission for Postsecondary Education Act, construct,

1 lease, purchase, purchase on contract, operate, equip, and maintain

- 2 facilities;
- 3 (5) Contract for services connected with the operation of
- 4 the community college area as needs and interest demand;
- 5 (6)(a) Cause a comprehensive audit of the books,
- 6 accounts, records, and affairs to be made annually covering the most
- 7 recently completed fiscal year. The audit of each area shall include
- 8 all sources of revenue used to finance operating expenditures and
- 9 capital improvements and the county-certified property valuation for
- 10 the community college for the fiscal year for which such audit is
- 11 being performed. Such audit of the books, accounts, records, and
- 12 affairs shall be completed and filed with the Auditor of Public
- 13 Accounts, the commission, and the Department of Administrative
- 14 Services on or before October November 15 of each year; and
- 15 (b) Cause a comprehensive audit of the full-time
- 16 equivalent student enrollment totals and reimbursable educational
- 17 unit totals to be made annually covering the most recently completed
- 18 fiscal year. The audit of each area shall include a report of full-
- 19 time equivalent student enrollment totals and reimbursable
- 20 educational unit totals verified by such audits for the three most
- 21 recently completed fiscal years which shall be used for calculation
- 22 of aid to the community college areas for fiscal year 2013-14 and
- 23 each fiscal year thereafter pursuant to subdivisions (3)(b) and (c)
- 24 of section 85-2234. The audit of the full-time equivalent student
- 25 enrollment totals and reimbursable educational unit totals shall be

1 completed and filed with the Auditor of Public Accounts, the

- 2 commission, and the Department of Administrative Services on or
- 3 before August 15 of each year;
- 4 (7) Establish fees and charges for the facilities
- 5 authorized by sections 85-1501 to 85-1540. Such fees and charges
- 6 shall be identified as facility fees at the time they are assessed.
- 7 The revenue from such fees and charges, other than revenue pledged to
- 8 retire bonds issued pursuant to sections 85-1515 and 85-1520 to
- 9 85-1527 and deposited in a separate bond sinking fund, shall be
- 10 deposited in the capital improvement and bond sinking fund provided
- 11 for in section 85-1515. Each board may enter into agreements with
- 12 owners of facilities to be used for housing regarding the management,
- 13 operation, and government of such facilities and may employ necessary
- 14 employees to govern, manage, and operate such facilities;
- 15 (8) Receive such gifts, grants, conveyances, and bequests
- 16 of real and personal property from public or private sources as may
- 17 be made from time to time, in trust or otherwise, whenever the terms
- 18 and conditions thereof will aid in carrying out the community college
- 19 programs as specified by law. Each board may sell, lease, exchange,
- 20 invest, or expend such gifts, grants, conveyances, and bequests or
- 21 the proceeds, rents, profits, and income therefrom according to the
- 22 terms and conditions thereof and adopt and promulgate rules and
- 23 regulations governing the receipt and expenditure of such proceeds,
- 24 rents, profits, and income, except that acceptance of such gifts,
- 25 grants, or conveyances shall not be conditioned on matching state or

- 1 local funds;
- 2 (9) Prescribe the courses of study for any community
- 3 college under its control and publish such catalogs and bulletins as
- 4 may be necessary;
- 5 (10) Grant to every student upon graduation or completion
- 6 of a course of study a suitable diploma, associate degree, or
- 7 certificate;
- 8 (11) Adopt and promulgate such rules and regulations and
- 9 perform all other acts as the board may deem necessary or appropriate
- 10 to the administration of the community college area. Such rules and
- 11 regulations shall include, but not be limited to, rules and
- 12 regulations relating to facilities, housing, scholarships,
- 13 discipline, and pedestrian and vehicular traffic on property owned,
- 14 operated, or maintained by the community college area;
- 15 (12) Employ, for a period to be fixed by the board, an
- 16 executive officer for the community college area and, by written
- 17 order filed in its office, delegate to such executive officer any of
- 18 the powers and duties vested in or imposed upon it by sections
- 19 85-1501 to 85-1540. Such delegated powers and duties may be exercised
- 20 in the name of the board;
- 21 (13) Acquire real property by eminent domain pursuant to
- 22 sections 76-701 to 76-724;
- 23 (14) Acquire real and personal property and sell, convey,
- 24 or lease such property whenever the community college area will be
- 25 benefited thereby. The sale, conveyance, or lease of any real estate

1 owned by a community college area shall be effective only when

- 2 authorized by an affirmative vote of at least two-thirds of all the
- 3 members of the board;
- 4 (15) Enter into agreements for services, facilities, or
- 5 equipment and for the presentation of courses for students when such
- 6 agreements are deemed to be in the best interests of the education of
- 7 the students involved;
- 8 (16) Transfer tribally controlled community college state
- 9 aid amounts to a tribally controlled community college located within
- 10 its community college area;
- 11 (17) Invest, after proper consideration of the
- 12 requirements for the availability of money, funds of the community
- 13 college in securities the nature of which individuals of prudence,
- 14 discretion, and intelligence acquire or retain in dealing with the
- 15 property of another;
- 16 (18) Establish tuition rates for courses of instruction
- 17 offered by each community college within its community college area.
- 18 Separate tuition rates shall be established for students who are
- 19 nonresidents of the State of Nebraska. Each board may also establish
- 20 fees to support the operating expenditures of the community college
- 21 area if such fees are accounted for separately from the fees and
- 22 charges established for facilities pursuant to subdivision (7) of
- 23 this section and are identified as operating fees at the time they
- 24 are assessed;
- 25 (19) Establish a fiscal year for the community college

- 1 area which conforms to the fiscal year of the state;
- 2 (20) Enter into a memorandum of understanding with the
- 3 State Board of Education to adopt a policy to share student data. At
- 4 a minimum, the policy shall ensure that the exchange of information
- 5 is conducted in conformance with the requirements of the federal
- 6 Family Educational Rights and Privacy Act of 1974, as amended, 20
- 7 U.S.C. 1232g, and all federal regulations and applicable guidelines
- 8 adopted in accordance with such act, as such act, regulations, and
- 9 guidelines existed on January 1, 2010; and
- 10 (21) Exercise any other powers, duties, and
- 11 responsibilities necessary to carry out sections 85-1501 to 85-1540.
