A BILL

- FOR AN ACT relating to schools; to amend section 79-10,138, Reissue
 Revised Statutes of Nebraska; to change provisions
 relating to reimbursement for school breakfast programs;
 to create a fund; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 79-10,138, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 79-10,138 (1) The State Department of Education shall
- 4 reimburse each qualified public school in Nebraska a portion of the
- 5 cost of such school's school breakfast program in the amount of five
- 6 cents per school breakfast served by such school in the second
- 7 preceding school year. To qualify, a school district shall operate a
- 8 school lunch program and shall submit information regarding the
- 9 number of breakfasts served in a manner prescribed by the department.
- 10 The Legislature shall appropriate money from the General Fund to
- 11 <u>carry out this subsection.</u>
- 12 <u>(2) The department shall also provide grants to</u>
- 13 qualifying school districts that: (a) Operate a school breakfast
- 14 program; (b) submit information regarding the number of breakfasts
- 15 served in a manner prescribed by the department; (c) agree to
- 16 implement alternative flexible models of school breakfast shown to
- 17 <u>increase participation, such as grab-and-go breakfast and breakfast</u>
- 18 in the classroom; (d) amend written policies to include the new
- 19 breakfast models and sign a memorandum of understanding with the
- 20 <u>department</u>, <u>agreeing</u> to <u>increase</u> <u>breakfast</u> <u>participation</u> <u>rates</u>
- 21 through the use of the alternative models; and (e) collect data
- 22 <u>showing average daily participation percentage.</u>
- 23 (3)(a) A school district that qualifies pursuant to
- 24 <u>subsection (2) of this section shall receive a one-time grant based</u>
- 25 on enrollment as follows: A school with fewer than two hundred

1 students shall receive two thousand dollars; a school with at least

- 2 two hundred students and not more than five hundred students shall
- 3 receive three thousand dollars; and a school with more than five
- 4 hundred students shall receive five thousand dollars. Schools that
- 5 have implemented alternative breakfast models before the effective
- 6 date of this act are not eligible for a grant under this section. The
- 7 Legislature shall appropriate money from the General Student Wellness
- 8 Fund to carry out this section. subsection.
- 9 (b) If more schools qualify than there are funds
- 10 <u>available</u>, <u>priority shall be given to schools in which at least half</u>
- 11 of the students are eligible for free or reduced-price lunch.
- 12 <u>(4) The Student Wellness Fund is created for the purpose</u>
- of receiving funds appropriated by the Legislature to carry out this
- 14 section and private funds to expand school breakfast participation
- and encourage other school wellness activities.
- 16 (5) The department shall contract with an outside entity
- 17 to administer the Student Wellness Fund, but no more than ten percent
- 18 of the money in the Student Wellness Fund may be used for
- 19 <u>administrative expenses</u>.
- 20 (6) No grants shall be made pursuant to this subsection
- 21 after May 1, 2017, or when the funds appropriated to the Student
- 22 Wellness Fund for such grants are depleted, whichever occurs earlier.
- 23 (7) Any money in the Student Wellness Fund available for
- 24 <u>investment shall be invested by the state investment officer pursuant</u>
- 25 to the Nebraska Capital Expansion Act and the Nebraska State Funds

- 1 <u>Investment Act.</u>
