

AMENDMENTS TO LB957

Introduced by Appropriations.

1 1. Strike the original sections and insert the following new
2 sections:

3 Section 1. Section 2-1507, Revised Statutes Supplement, 2015, is
4 amended to read:

5 2-1507 (1) It is the intent of the Legislature that the Water
6 Sustainability Fund be equitably distributed statewide to the greatest
7 extent possible for the long term and give priority funding status to
8 projects which are the result of federal mandates.

9 (2) Distributions to assist municipalities with the cost of
10 constructing, upgrading, developing, and replacing sewer infrastructure
11 facilities as part of a combined sewer overflow project shall be based on
12 a demonstration of need and shall equal ten percent of the total annual
13 appropriation to the Water Sustainability Fund if (a) applicants have
14 applied for such funding as required under section 2-1509 and (b) any
15 such application has been recommended for further consideration by the
16 director and is subsequently approved for allocation by the commission
17 pursuant to subsection (1) of section 2-1511. If more than one
18 municipality demonstrates a need for funds pursuant to this subsection,
19 funds shall be distributed proportionally based on population.

20 (3) Any money in the Water Sustainability Fund may be allocated by
21 the commission to applicants in accordance with sections 2-1506 to
22 2-1513. Such money may be allocated in the form of grants or loans for
23 water sustainability programs, projects, or activities undertaken within
24 the state. The allocation of funds to a program, project, or activity in
25 one form shall not of itself preclude additional allocations in the same
26 or any other form to the same program, project, or activity.

27 (4) When the commission has approved an allocation of funds to a

1 program, project, or activity, the Department of Natural Resources shall
2 establish a subaccount in the Water Sustainability Fund and credit the
3 entire amount of the allocation to the subaccount. Individual subaccounts
4 shall be established for each program, project, or activity approved by
5 the commission. The commission may approve a partial allocation to a
6 program, project, or activity based upon available unallocated funds in
7 the Water Sustainability Fund, but the amount of unfunded allocations
8 shall not exceed eleven million dollars. Additional allocations to a
9 program, project, or activity shall be credited to the same subaccount as
10 the original allocation. Subaccounts shall not be subject to transfer out
11 of the Water Sustainability Fund, except that the commission may
12 authorize the transfer of excess or unused funds from a subaccount and
13 into the unreserved balance of the fund.

14 (5) A natural resources district is eligible for funding from the
15 Water Sustainability Fund only if the district has adopted or is
16 currently participating in the development of an integrated management
17 plan pursuant to subdivision (1)(a) or (b) of section 46-715.

18 (6) The commission shall utilize the resources and expertise of and
19 collaborate with the Department of Natural Resources, the University of
20 Nebraska, the Department of Environmental Quality, the Nebraska
21 Environmental Trust Board, and the Game and Parks Commission on funding
22 and planning for water programs, projects, or activities.

23 (7) A biennial report shall be made to the Clerk of the Legislature
24 describing the work accomplished by the use of funds towards the goals of
25 the Water Sustainability Fund beginning on December 31, 2015. The report
26 submitted to the Clerk of the Legislature shall be submitted
27 electronically.

28 Sec. 2. Section 37-913, Reissue Revised Statutes of Nebraska, is
29 amended to read:

30 37-913 (1) There is hereby created the Cowboy Trail Fund. Any money
31 in the fund available for investment shall be invested by the state

1 investment officer pursuant to the Nebraska Capital Expansion Act and the
2 Nebraska State Funds Investment Act. Money accepted or transferred
3 pursuant to subsection (3) of section 37-912 shall be remitted to the
4 State Treasurer for credit to the fund.

5 (2) The State Treasurer shall transfer one hundred thousand dollars
6 from the Nebraska Youth Conservation Program Fund on the effective date
7 of this act to the Cowboy Trail Fund. The Game and Parks Commission shall
8 use money transferred to the Cowboy Trail Fund under this subsection for
9 the development of undeveloped portions of the Cowboy Trail but shall not
10 expend any money under this subsection unless the amount is matched both
11 by a public entity and by a private entity for each expenditure.

14 60-1513 The Department of Motor Vehicles Cash Fund is hereby
15 created. The fund shall be administered by the Director of Motor
16 Vehicles. The fund shall be used by the Department of Motor Vehicles to
17 carry out its duties as deemed necessary by the Director of Motor
18 Vehicles, except that transfers from the fund to the General Fund or the
19 Vehicle Title and Registration System Replacement and Maintenance Cash
20 Fund may be made at the direction of the Legislature. Any money in the
21 Department of Motor Vehicles Cash Fund available for investment shall be
22 invested by the state investment officer pursuant to the Nebraska Capital
23 Expansion Act and the Nebraska State Funds Investment Act.

4 rebates under the Nebraska Clean-burning Motor Fuel Development Act up to

5 the State Treasurer for credit to the fund. The fund shall consist of
6 such funds and legislative appropriations made to the council. Transfers
7 may be made from the fund to the General Fund at the direction of the

22 homes to low-income medically underserved populations. Twenty-five
23 percent of the state portion of federal medicaid fraud settlement funds
24 deposited into the Medicaid Fraud Settlement Fund in the Department of
25 Health and Human Services accruing to Nebraska annually shall be
26 transferred to deposited in the Health Care Homes for the Medically
27 Underserved Fund for distribution to federally qualified health centers
28 in Nebraska. Such funds shall be distributed proportionately based on the
29 unduplicated number of patients served in the previous year by such
30 federally qualified health centers as reported through the uniform data
