2 sections:

3 Section 1. Section 14-419, Reissue Revised Statutes of Nebraska, is
4 amended to read:

5 14-419 The city council, in cities of the metropolitan class, shall
6 have the power by ordinance to regulate, within the corporate limits of
7 the city or in areas within three miles of the corporate limits, except
8 as to construction on farms for farm purposes, (1) the minimum standards
9 of construction of buildings, dwellings, and other structures, in order
10 to provide safe and sound condition thereof for the preservation of
11 health, safety, security, and general welfare, and as to electric wiring,
12 heating, plumbing, pipefitting, sewer connections, ventilation, size of
13 habitable rooms, and the method of constructing buildings, and to provide
14 for inspection thereof and building permits, (2) the removal and tearing
15 down of buildings, dwellings, and other structures in such areas which
16 constitute nuisances because of the dilapidated, unsafe, or rundown
17 condition or conditions, and (3) except as to the United States of
18 America, the State of Nebraska, any county of the state, or any city or
19 village in the state, the nature, kind, and manner of constructing
20 streets, alleys, sidewalks, curbing or abridging curbs, driveway
21 approaches constructed on public right-of-way, and sewers. Any building
22 or construction code implemented under this section shall be adopted and
23 enforced as provided in section 71-6406.

24 Sec. 2. Section 15-905, Revised Statutes Cumulative Supplement,
25 2014, is amended to read:

26 15-905 Every city of the primary class may regulate in the area
27 which is within the corporate limits of the city or within three miles of

1 the corporate limits of the city and outside of any organized city or
2 village, except as to construction on farms for farm purposes, (1) the
3 minimum standards of construction of buildings, dwellings, and other
4 structures in order to provide safe and sound condition thereof for the
5 preservation of health, safety, security, and general welfare, which
6 standards may include regulations as to electric wiring, heating,
7 plumbing, pipefitting, sewer connections, ventilation, size of habitable
8 rooms, and the method of constructing buildings, dwellings, and other
9 structures, and to provide for inspection thereof, and building permits
10 and fees for such permits therefor, (2) the removal and tearing down of
11 buildings, dwellings, and other structures in such areas which constitute
12 nuisances because of the dilapidated, unsafe, or rundown condition or
13 conditions, and (3) except as to the United States of America, the State
14 of Nebraska, a county, or a village, in the area outside of the corporate
15 limits of the city of the primary class, the nature, kind, and manner of
16 constructing streets, alleys, sidewalks, curbing or abridging curbs,
17 driveway approaches constructed on or to public right-of-way, and sewage
18 disposal facilities. Any building or construction code implemented under
19 this section shall be adopted and enforced as provided in section
20 71-6406.

21 Sec. 3. Section 16-102, Reissue Revised Statutes of Nebraska, is
22 amended to read:

23 16-102 Whenever any city of the second class attains a population of
24 more than five thousand inhabitants as provided by section 16-101, the
25 mayor of such city shall certify such fact to the Secretary of State who
26 upon the filing of such certificate shall by proclamation declare such
27 city to be a city of the first class. Upon such proclamation being made
28 by the Secretary of State, every officer of such city ~~cities~~ shall,
29 within thirty days thereafter, qualify and give bond as provided by
30 sections 16-219, 16-304, and 16-318.

31 Sec. 4. Section 16-103, Reissue Revised Statutes of Nebraska, is

1 amended to read:

2 16-103 (1) After the proclamation under section 16-102, the city
3 shall be governed by the laws of this state applicable to cities of the
4 first class, except that the government of such city shall continue as
5 organized at the date of such proclamation until the reorganization as a
6 city of the first class.

7 (2) The mayor and city council members of the city of the second
8 class shall be deemed to be the mayor and city council members of the
9 city of the first class on the date the proclamation is issued. All
10 ordinances, bylaws, acts, rules, regulations, obligations, and
11 proclamations existing and in force in or with respect to the city of the
12 second class at the time of its incorporation as a city of the first
13 class shall remain in full force and effect after such incorporation
14 until repealed or modified by the city within one year after the date of
15 the filing of the certificate pursuant to section 16-102.

16 (3) For the purpose of electing city officials under the provisions
17 of law relating to cities of the first class, the terms of office for
18 such officials shall be established by the city council ~~city's governing~~
19 ~~body~~ so as to conform with the intent and purpose of section 32-534.

20 Sec. 5. Section 16-104, Reissue Revised Statutes of Nebraska, is
21 amended to read:

22 16-104 If a city of the second class becomes a city of the first
23 class, the mayor and city council shall divide the city into not less
24 than three wards, as compact in form and equal in population as may be,
25 the boundaries of which shall be defined by ordinance, to take effect at
26 the next annual city election after reorganization except as provided in
27 section 32-553. Each ward shall constitute an election district, except
28 that when any ward has over five hundred legal voters, the mayor and city
29 council may divide such ward into two or more election districts. If it
30 is necessary to establish the staggering of terms by nominating and
31 electing council members for terms of different durations at the same

1 elections, the candidates receiving the greatest number of votes shall be
2 nominated and have their names placed on the general election ballot.

3 Sec. 6. Section 16-105, Reissue Revised Statutes of Nebraska, is
4 amended to read:

5 16-105 Precinct lines in any part of any county not under township
6 organization, embraced within the corporate limits of a city of the first
7 class ~~such city~~, shall correspond with the ward lines of the city, and
8 such precinct shall correspond in number with the ward of the city and be
9 coextensive with the ward. When same; ~~Provided, when~~ a ward is divided
10 into election districts, the precinct corresponding with such ward shall
11 be divided so as to correspond with the election districts.

12 Sec. 7. Section 16-117, Reissue Revised Statutes of Nebraska, is
13 amended to read:

14 16-117 (1) Except as provided in sections 13-1111 to 13-1120 and
15 16-130 and subject to this section, the mayor and city council of a city
16 of the first class may by ordinance at any time include within the
17 corporate limits of such city any contiguous or adjacent lands, lots,
18 tracts, streets, or highways as are urban or suburban in character and in
19 such direction as may be deemed proper. Such grant of power shall not be
20 construed as conferring power upon the mayor and city council to extend
21 the limits of a city of the first class over any agricultural lands which
22 are rural in character.

23 (2) The invalidity of the annexation of any tract of land in one
24 ordinance shall not affect the validity of the remaining tracts of land
25 which are annexed by the ordinance and which otherwise conform to state
26 law.

27 (3) The city council proposing to annex land under the authority of
28 this section shall first adopt both a resolution stating that the city is
29 proposing the annexation of the land and a plan for extending city
30 services to the land. The resolution shall state:

31 (a) The time, date, and location of the public hearing required by

1 subsection (5) of this section;

2 (b) A description of the boundaries of the land proposed for
3 annexation; and

4 (c) That the plan of the city for the extension of city services to
5 the land proposed for annexation is available for inspection during
6 regular business hours in the office of the city clerk.

7 (4) The plan adopted by the city council shall contain sufficient
8 detail to provide a reasonable person with a full and complete
9 understanding of the proposal for extending city services to the land
10 proposed for annexation. The plan shall (a) state the estimated cost
11 impact of providing the services to such land, (b) state the method by
12 which the city plans to finance the extension of services to the land and
13 how any services already provided to the land will be maintained, (c)
14 include a timetable for extending services to the land proposed for
15 annexation, and (d) include a map drawn to scale clearly delineating the
16 land proposed for annexation, the current boundaries of the city, the
17 proposed boundaries of the city after the annexation, and the general
18 land-use pattern in the land proposed for annexation.

19 (5) A public hearing on the proposed annexation shall be held within
20 sixty days following the adoption of the resolution proposing to annex
21 land to allow the city council to receive testimony from interested
22 persons. The city council may recess the hearing, for good cause, to a
23 time and date specified at the hearing.

24 (6) A copy of the resolution providing for the public hearing shall
25 be published in a legal ~~the official~~ newspaper in or of general
26 circulation in the city at least once not less than ten days preceding
27 the date of the public hearing. A map drawn to scale delineating the land
28 proposed for annexation shall be published with the resolution. A copy of
29 the resolution providing for the public hearing shall be sent by first-
30 class mail following its passage to the school board of any school
31 district in the land proposed for annexation.

1 (7) Any owner of property contiguous or adjacent to a city of the
2 first class may by petition request that such property be included within
3 the corporate limits of such city. The mayor and city council may include
4 such property within the corporate limits of the city without complying
5 with subsections (3) through (6) of this section.

6 (8) Notwithstanding the requirements of this section, the mayor and
7 city council are not required to approve any petition requesting
8 annexation or any resolution or ordinance proposing to annex land
9 pursuant to this section.

10 Sec. 8. Section 16-119, Reissue Revised Statutes of Nebraska, is
11 amended to read:

12 16-119 Any extraterritorial zoning regulations, property use
13 regulations, or other laws, codes, rules, or regulations imposed upon any
14 annexed lands by the city before such annexation shall continue in full
15 force and effect until otherwise changed.

16 Sec. 9. Section 16-120, Reissue Revised Statutes of Nebraska, is
17 amended to read:

18 16-120 The inhabitants of territories annexed by a ~~to such~~ city of
19 the first class shall receive substantially the services of other
20 inhabitants of such city as soon as practicable. Adequate plans and
21 necessary city council action to furnish such services shall be adopted
22 not later than one year after the date of annexation, and such
23 inhabitants shall be subject to the ordinances and regulations of such
24 city, except that the one-year period shall be tolled pending final court
25 decision in any court action to contest such annexation.

26 Sec. 10. Section 16-122, Reissue Revised Statutes of Nebraska, is
27 amended to read:

28 16-122 In addition to existing annexation powers, the mayor and city
29 council of any city of the first class may by ordinance annex any village
30 or ~~second-class~~ city of the second class which is entirely surrounded by
31 such city of the first class, if the following conditions exist:

1 (1) The city has water mains adjacent to the village or ~~second-class~~
2 city of the second class which are available for extension into and have
3 capacity to serve the village or ~~second-class~~ city of the second class;

4 (2) The city has sanitary sewer lines adjacent to the village or
5 ~~second-class~~ city of the second class which are available for extension
6 into and have capacity to serve the village or ~~second-class~~ city of the
7 second class;

8 (3) The city has water and sewer treatment facilities which have the
9 capacity to serve the village or ~~second-class~~ city of the second class;
10 and

11 (4) The city has police, fire, and snow removal facilities which
12 have the capacity to serve the village or ~~second-class~~ city of the second
13 class.

14 In determining whether a village or ~~second-class~~ city of the second
15 class is entirely surrounded by a city for annexation purposes, any land
16 adjacent to the village or ~~second-class~~ city of the second class which is
17 legally immune from annexation by either the city or the village, or
18 ~~second-class~~ city of the second class, shall not be considered if the
19 village or ~~second-class~~ city of the second class is otherwise surrounded
20 by the city.

21 Sec. 11. Section 16-124, Reissue Revised Statutes of Nebraska, is
22 amended to read:

23 16-124 Whenever any city of the first class extends ~~shall extend~~ its
24 boundaries so as to annex any village or ~~second-class~~ city of the second
25 class, the charter, laws, ordinances, powers, and government of such city
26 of the first class shall at once extend over the territory ~~embraced~~
27 within any village or ~~second-class~~ city of the second class so annexed.
28 Such city of the first class shall succeed to all the property and
29 property rights of every kind, contracts, obligations, and choses in
30 action of every kind held by or belonging to the village or ~~second-class~~

18 city of the first class.

19 Sec. 13. Section 16-126, Reissue Revised Statutes of Nebraska, is

21 16-126 All taxes and special assessments which a ~~such~~ village or
22 ~~second-class~~ city of the second class so annexed under section 16-122 was
23 authorized to levy or assess and which are not levied or assessed at the
24 time of such annexation for any kind of public improvements made ~~by it~~ or

16 section 16-201, shall be exercised by ordinance directing the conveyance
17 of such real estate and the manner and terms thereof. Notice of such sale
18 and the terms thereof shall be published for three consecutive weeks in a
19 legal newspaper ~~published~~ in or of general circulation in such city
20 immediately after the passage and publication of such ordinance.

21 If within thirty days after the passage and publication of such

31 next business day. Upon the receipt of the petition ~~remonstrance~~, the

1 ~~city council governing body of such city~~, with the aid and assistance of
2 the election commissioner or county clerk, shall determine the validity
3 and sufficiency of signatures on the petition remonstrance. The city
4 ~~council governing body of such city~~ shall deliver the petition
5 ~~remonstrance~~ to the election commissioner or county clerk by hand
6 carrier, by use of law enforcement officials, or by certified mail,
7 return receipt requested. Upon receipt of the petition remonstrance, the
8 election commissioner or county clerk shall issue to the city council
9 ~~governing body~~ a written receipt that the petition remonstrance is in the
10 custody of the election commissioner or county clerk. The election
11 commissioner or county clerk shall compare the signature of each person
12 signing the petition remonstrance with the voter registration records to
13 determine if each signer was a registered voter on or before the date on
14 which the petition remonstrance was filed with the city council governing
15 ~~body~~. The election commissioner or county clerk shall also compare the
16 signer's printed name, street and number or voting precinct, and city,
17 village, or post office address with the voter registration records to
18 determine whether the signer was a registered voter. The signature and
19 address shall be presumed to be valid only if the election commissioner
20 or county clerk determines that the printed name, street and number or
21 voting precinct, and city, village, or post office address matches the
22 registration records and that the registration was received on or before
23 the date on which the petition remonstrance was filed with the city
24 ~~council governing body~~. The determinations of the election commissioner
25 or county clerk may be rebutted by any credible evidence which the city
26 ~~council governing body~~ finds sufficient. The express purpose of the
27 comparison of names and addresses with the voter registration records, in
28 addition to helping to determine the validity of the petition
29 ~~remonstrance~~, the sufficiency of the petition remonstrance, and the
30 qualifications of the signer, shall be to prevent fraud, deception, and
31 misrepresentation in the petition remonstrance process. Upon completion

1 of the comparison of names and addresses with the voter registration
2 records, the election commissioner or county clerk shall prepare in
3 writing a certification under seal setting forth the name and address of
4 each signer found not to be a registered voter and the signature page
5 number and line number where the name is found, and if the reason for the
6 invalidity of the signature or address is other than the nonregistration
7 of the signer, the election commissioner or county clerk shall set forth
8 the reason for the invalidity of the signature. If the election
9 commissioner or county clerk determines that a signer has affixed his or
10 her signature more than once to the petition remonstrance and that only
11 one person is registered by that name, the election commissioner or
12 county clerk shall prepare in writing a certification under seal setting
13 forth the name of the duplicate signature and shall count only the
14 earliest dated signature. The election commissioner or county clerk shall
15 certify to the city council governing body the number of valid signatures
16 necessary to constitute a valid petition remonstrance. The election
17 commissioner or county clerk shall deliver the petition remonstrance and
18 the certifications to the city council governing body within forty days
19 after the receipt of the petition remonstrance from the city council
20 governing body. The delivery shall be by hand carrier, by use of law
21 enforcement officials, or by certified mail, return receipt requested.
22 Not more than twenty signatures on one signature page shall be counted.

23 The city council governing body shall, within thirty days after the
24 receipt of the petition remonstrance and certifications from the election
25 commissioner or county clerk, hold a public hearing to review the
26 petition remonstrance and certifications and receive testimony regarding
27 them. The city council governing body shall, following the hearing, vote
28 on whether or not the petition remonstrance is valid and shall uphold the
29 petition remonstrance if sufficient valid signatures have been received.

31 amended to read:

1 16-206 A city of the first class may collect a license tax from the
2 owners and harborers of dogs and other animals in an amount which shall
3 be determined by the city council ~~governing body of such city~~ and enforce
4 the license tax ~~same~~ by appropriate penalties. Any licensing provision
5 shall comply with subsection (2) of section 54-603 for service animals.
6 The city may cause the destruction of any dog or other animal, for which
7 the owner or harborer shall refuse or neglect to pay such license tax.
8 The city ~~It~~ may regulate, license, or prohibit the running at large of
9 dogs and other animals and guard against injuries or annoyances therefrom

13 amended to read:

14 16-207 (1) A city of the first class may by ordinance provide for
15 the removal of all obstructions from the sidewalks, curbstones, gutters,
16 and crosswalks at the expense of the owners or occupants of the grounds
17 fronting thereon or at the expense of the person placing the obstruction
18 and may require and regulate the planting and protection of shade trees
19 in and along the streets and the trimming and removing of the trees.

20 (2) A city of the first class may by ordinance declare it to be a
21 nuisance for a property owner to permit, allow, or maintain any dead or
22 diseased trees within the right-of-way of streets within the corporate
23 limits of the city or within its extraterritorial ~~two-mile~~ zoning
24 jurisdiction. Notice to abate and remove such nuisance and notice of the
25 right to a hearing and the manner in which it may be requested shall be
26 given to each owner or owner's duly authorized agent and to the occupant,
27 if any, by personal service or certified mail. Within thirty days after
28 the receipt of such notice, if the owner or occupant of the lot or piece
29 of ground does not request a hearing or fails to comply with the order to
30 abate and remove the nuisance, the city may have such work done and may
31 levy and assess all or any portion of the costs and expenses of the work

1 upon the lot or piece of ground so benefited as a special assessment.

2 (3) The city may also regulate the building of bulkheads, cellars,
3 basements, ways, stairways, railways, windows, doorways, awnings,
4 ~~hitching posts and rails,~~ lampposts, awning posts, and all other
5 structures projecting upon or over any adjoining excavation through and
6 under the sidewalks in the city.

7 Sec. 20. Section 16-212, Reissue Revised Statutes of Nebraska, is
8 amended to read:

9 16-212 A city of the first class by ordinance may regulate the
10 crossing of railway tracks and provide precautions and prescribe rules
11 regulating the same, ~~;~~ regulate the running of railway engines, cars, and
12 trucks within the limits of such ~~said~~ city, and prescribe rules relating
13 thereto, and govern the speed thereof, ~~;~~ and make other and further
14 provisions, rules, and restrictions to prevent accidents at the crossings
15 and on the tracks of railways, and to prevent fires from engines. A city
16 of the first class may ~~It may~~ regulate and prescribe the manner of
17 running street cars, require the heating and cleaning of such cars ~~same,~~

28 and the expense ~~same~~ shall constitute a lien on any real estate belonging
29 to such company, and lying within such ~~said~~ city, and may be collected in
30 the same manner as taxes for general purposes. The city may (1) require
31 railroad companies to keep flagmen at all railroad crossings of streets,

1 and provide protection against injury to persons and property in the use
2 of such railroads, (2) ÷ compel any railroad to raise or lower their
3 railroad tracks to conform to the general grade, which may at any time be
4 established by such city, and where such tracks run lengthwise through or
5 over any street, alley, or highway, to keep the tracks same level with
6 the street surface, and (3) ÷ compel and require railroad companies to
7 keep open the streets, and to construct and keep in repair ditches,
8 drains, sewers, and culverts, along and under their railroad tracks, and
9 to pave their whole right-of-way on all paved streets, and keep the
10 right-of-way and tracks same in repair.
