14 29-4006 (1) Registration information required by the Sex Offender
15 Registration Act shall be entered into a data base in a format approved
16 by the sex offender registration and community notification division of
17 the Nebraska State Patrol and shall include, but not be limited to, the
18 following information:

19 (a) The legal name and all aliases which the person has used or
20 under which the person has been known;

21 (b) The person's date of birth and any alias dates of birth;

22 (c) The person's social security number;

23 (d) The address of each residence at which the person resides, has a
24 temporary domicile, has a habitual living location, or will reside;

25 (e) The name and address of any place where the person is an
26 employee or will be an employee, including work locations without a
27 single worksite;

28 (f) The name and address of any place where the person is a student
29 or will be a student;

30 (g) The license plate number and a description of any vehicle owned
31 or operated by the person and its regular storage location;

12 the sheriff of the county in which he or she resides, has a temporary
13 domicile, or is habitually living for purposes of accepting verifications
14 and shall have his or her photograph and fingerprints taken upon request
15 of verification personnel.

16 (3 ~~4~~) A person required to register under the act for fifteen years
17 shall report every twelve months in the month of his or her birth, in
18 person, to the office of the sheriff of the county in which he or she
19 resides for purposes of accepting verifications, regardless of the
20 original registration month. The sheriff shall submit such verification
21 information to the sex offender registration and community notification
22 division of the Nebraska State Patrol on the day it is received and in a

25 years shall report, in person, every six months to the office of the
26 sheriff of the county in which he or she resides for purposes of
27 accepting verification. The person shall report, in person, in the month
28 of his or her birth and in the sixth month following the month of his or
29 her birth, regardless of the original registration month. The sheriff
30 shall submit such verification information to the sex offender
31 registration and community notification division of the Nebraska State

1 Patrol on the day it is received and in a manner prescribed by the
2 Nebraska State Patrol for such purpose.

3 (5 ~~6~~) A person required to register under the act for life shall
4 report, in person, every three months to the office of the sheriff of the
5 county in which he or she resides for purposes of accepting verification.
6 The person shall report, in person, in the month of his or her birth and
7 every three months following the month of his or her birth, regardless of
8 the original registration month. The sheriff shall submit such
9 verification information to the sex offender registration and community
10 notification division of the Nebraska State Patrol on the day it is
11 received and in a manner prescribed by the Nebraska State Patrol for such
12 purpose.

13 (6 ~~7~~) The verification form shall be signed by the person required
14 to register under the act and state whether the address last reported to
15 the division is still correct.

16 (7 ~~8~~) Upon receipt of registration and confirmation of the registry
17 requirement, the sex offender registration and community notification
18 division of the Nebraska State Patrol shall notify the person by
19 certified mail of his or her registry duration and verification schedule.

20 (8 ~~9~~) If the person required to register under the act fails to
21 report in person as required in subsection (3), (4), or (5), ~~or~~ ~~(6)~~ of
22 this section, the person shall be in violation of this section.

23 (9 ~~10~~) If the person required to register under the act falsifies
24 the registration or verification information or form or fails to provide
25 or timely update law enforcement of any of the information required to be
26 provided by the Sex Offender Registration Act, the person shall be in

29 register under the act shall not apply during periods of such person's

12 who has pled guilty or has been found guilty of a registrable offense
13 under section 29-4003. The written notification shall:

14 (i) Inform the defendant of whether or not he or she is subject to
15 the act, the duration of time he or she will be subject to the act, and
16 that he or she shall report to a location designated by the Nebraska
17 State Patrol for purposes of accepting such registration within three
18 working days after the date of the written notification to register;

19 (ii) Inform the defendant that if he or she moves to another address
20 within the same county, he or she must report to the county sheriff of
21 the county in which he or she is residing within three working days
22 before his or her move;

23 (iii) Inform the defendant that if he or she no longer has a
24 residence, temporary domicile, or habitual living location, he or she
25 shall report such change in person to the sheriff of the county in which
26 he or she is located within three working days after such change in
27 residence, temporary domicile, or habitual living location;

29 (2) When a person is convicted of a registrable offense under
30 section 29-4003 and is not subject to immediate incarceration upon

2 office or other location designated by the patrol for purposes of
3 accepting registrations.

4 (3)(a) The Department of Correctional Services or a city or county
5 correctional or jail facility shall provide written notification of the
6 duty to register pursuant to the Sex Offender Registration Act to any
7 person committed to its custody for a registrable offense under section
8 29-4003 prior to the person's release from incarceration. The written
9 notification shall:

21 (iii) Provide a copy of the signed, written notification to register
22 to the person and to the sex offender registration and community
23 notification division of the Nebraska State Patrol.

24 (4) If a person is convicted of a registrable offense under section
25 29-4003 and is immediately incarcerated, he or she shall be registered as
26 required under the act prior to discharge, parole, or work release.

27 (5) The Department of Motor Vehicles shall cause written
28 notification of the duty to register to be provided on the applications
29 for a motor vehicle operator's license and for a commercial driver's
