Explanation of Estimate:

LB1106 establishes a civil forfeiture procedure which will impact district court workload and judicial branch education.

The fiscal impact on district court judicial and staff resources is difficult to determine at this time since the number of new hearings and their length is unknown. In addition, forfeiture of any property must be specifically requested and is not required. However, since district court operating expenses are primarily a county expense any fiscal impact to the Supreme Court should not be significant.

Additional judicial branch education regarding LB1106 requirements and procedures can be completed with existing staff and funding.
