LB152 would expressly authorize the mayor and council of metropolitan, primary, first and second class cities and the board of trustees of villages to borrow (with certain limitations as provided by the bill) from a state or federally chartered bank, savings bank, building and loan association, or savings and loan association, for purchase of real or personal property or construction of improvements. Any related impact would be dependent upon future actions of municipalities to enter into such debt financing and the relative costs of such means of financing versus financing costs associated with other forms of debt financing authorized by law, i.e. tax anticipation notes, bonds, lease-purchase agreements.
