Explanation of Estimate:

LB189 is reducing criminal sanctions for marijuana concentrate drugs (including hashish and hash oil) that contain natural tetrahydrocannabinol (THC). The current penalty for hashish and hash oil is a Class IV felony, but LB 189 lessens the penalties for possession of an ounce or less of marijuana concentrate drugs, (including hashish and hash oil) to match the penalties for possession of an ounce or less of marijuana: infractions, misdemeanors, citations, courses, and possible jail time, escalating for repeat offenses.

Penalties for synthetically produced cannabinoids are also newly specified by LB 189. These penalties are also less than the felony currently imposed for possession, but harsher than for natural THC drugs: first offense is an infraction, fine and education. Subsequent convictions are Class IIIA misdemeanors, \$500 fine and up to seven days jail time.

There is no Fiscal Impact to the Department of Health and Human Services.
