A BILL FOR AN ACT relating to funds; to amend sections 37-913, 60-1513, 1 82-316, 82-326, 82-331, 84-1227, 85-419, 85-421, 85-422, 85-423, 2 85-424, and 85-425, Reissue Revised Statutes of Nebraska, sections 3 71-5714, 71-8805, and 72-2009, Revised Statutes Cumulative 4 5 Supplement, 2014, and sections 2-1507, 66-204, 81-3140, 81-3714, and 84-612, Revised Statutes Supplement, 2015; to provide for and change 6 7 distribution and use of certain funds; to provide for transfers and 8 investment of funds; to create and eliminate funds and programs; to 9 state intent; to change provisions relating to artwork in state 10 buildings and renovation and replacement of university and state college buildings; to eliminate obsolete provisions; to repeal the 11 original sections; to outright repeal sections 37-915, 37-916, 12 37-917, 37-918, 37-919, 37-920, and 37-921, Revised Statutes 13 14 Cumulative Supplement, 2014; and to declare an emergency.

1 Section 1. Section 2-1507, Revised Statutes Supplement, 2015, is

- 3 2-1507 (1) It is the intent of the Legislature that the Water
- 4 Sustainability Fund be equitably distributed statewide to the greatest
- 5 extent possible for the long term and give priority funding status to
- 6 projects which are the result of federal mandates.
- 7 (2) Distributions to assist municipalities with the cost of
- 8 constructing, upgrading, developing, and replacing sewer infrastructure
- 9 facilities as part of a combined sewer overflow project shall be based on
- 10 a demonstration of need and shall equal ten percent of the total annual
- 11 appropriation to the Water Sustainability Fund if (a) applicants have
- 12 applied for such funding as required under section 2-1509 and (b) any
- 13 such application has been recommended for further consideration by the
- 14 director and is subsequently approved for allocation by the commission
- 15 pursuant to subsection (1) of section 2-1511. If more than one
- 16 municipality demonstrates a need for funds pursuant to this subsection,
- 17 funds shall be distributed proportionally based on population.
- 18 (3) Any money in the Water Sustainability Fund may be allocated by
- 19 the commission to applicants in accordance with sections 2-1506 to
- 20 2-1513. Such money may be allocated in the form of grants or loans for
- 21 water sustainability programs, projects, or activities undertaken within
- 22 the state. The allocation of funds to a program, project, or activity in
- 23 one form shall not of itself preclude additional allocations in the same
- 24 or any other form to the same program, project, or activity.
- 25 (4) When the commission has approved an allocation of funds to a
- 26 program, project, or activity, the Department of Natural Resources shall
- 27 establish a subaccount in the Water Sustainability Fund and credit the
- 28 entire amount of the allocation to the subaccount. Individual subaccounts
- 29 shall be established for each program, project, or activity approved by
- 30 the commission. The commission may approve a partial allocation to a
- 31 program, project, or activity based upon available unallocated funds in

- 1 the Water Sustainability Fund, but the amount of unfunded allocations
- 2 <u>shall not exceed eleven million dollars.</u> Additional allocations to a
- 3 program, project, or activity shall be credited to the same subaccount as
- 4 the original allocation. Subaccounts shall not be subject to transfer out
- 5 of the Water Sustainability Fund, except that the commission may
- 6 authorize the transfer of excess or unused funds from a subaccount and
- 7 into the unreserved balance of the fund.
- 8 (5) A natural resources district is eligible for funding from the
- 9 Water Sustainability Fund only if the district has adopted or is
- 10 currently participating in the development of an integrated management
- 11 plan pursuant to subdivision (1)(a) or (b) of section 46-715.
- 12 (6) The commission shall utilize the resources and expertise of and
- 13 collaborate with the Department of Natural Resources, the University of
- 14 Nebraska, the Department of Environmental Quality, the Nebraska
- 15 Environmental Trust Board, and the Game and Parks Commission on funding
- 16 and planning for water programs, projects, or activities.
- 17 (7) A biennial report shall be made to the Clerk of the Legislature
- 18 describing the work accomplished by the use of funds towards the goals of
- 19 the Water Sustainability Fund beginning on December 31, 2015. The report
- 20 submitted to the Clerk of the Legislature shall be submitted
- 21 electronically.
