- 1 A BILL FOR AN ACT relating to the Game Law; to amend section 37-706,
- 2 Reissue Revised Statutes of Nebraska; to change provisions relating
- 3 to a game refuge as prescribed; and to repeal the original section.
- 4 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 37-706, Reissue Revised Statutes of Nebraska, is
- 2 amended to read:
- 3 37-706 (1) For the better protection of birds and the establishment
- 4 of breeding places therefor, the following area within the State of
- 5 Nebraska is hereby set aside, designated, and established as a state game
- 6 refuge: All that portion of the State of Nebraska on the North Platte
- 7 River and for one hundred ten yards back of the banks of the main channel
- 8 of said stream on the land side in Garden County, Nebraska.
- 9 (2) For the better protection of birds and the establishment of
- 10 breeding and resting places therefor, the following areas within the
- 11 State of Nebraska are hereby set aside, designated, and established as
- 12 state game refuges: (a) All that portion of the State of Nebraska on the
- 13 Platte River and for one hundred ten yards on each side of the banks of
- 14 said stream from the west line of Dodge County and Saunders County east
- 15 and southeast to the bridge across said Platte River, west of Venice,
- 16 Nebraska, on U.S. Route No. 30A and State Route No. 92; (b) all that
- 17 portion of the State of Nebraska embracing the channel or channels of the
- 18 Niobrara River and for one hundred ten yards back from the banks of such
- 19 stream on the land side in Boyd and Holt Counties, extending from the
- 20 west line of Boyd and Holt Counties on the west to State Highway No. 11
- 21 on the east; and (c) all that portion of the State of Nebraska on the
- 22 North Platte River, and for one hundred ten yards on each side of the
- 23 banks of the stream in sections twenty-one, twenty-six, twenty-seven,
- 24 twenty-eight, thirty-four, thirty-five, and thirty-six, township fourteen
- 25 north, range thirty, west of the sixth principal meridian, Lincoln
- 26 County, Nebraska.
- 27 (3) For purposes of sections 37-701 to 37-708, the banks of said
- 28 stream means the banks of the river which are the elevation of ground
- 29 which confines the water at a level not exceeding flood stage.
- 30 Sec. 2. Original section 37-706, Reissue Revised Statutes of
- 31 Nebraska, is repealed.
