PRESIDENT FOLEY: THANK YOU, MR. CLERK. SENATOR SCHEER, FOR WHAT PURPOSE DO YOU RISE?

SENATOR SCHEER: THANK YOU, MR. SPEAKER OR MR. PRESIDENT. I HAVE A MOMENT OF PERSONAL PRIVILEGE, PLEASE? COLLEAGUES, I WITH GREAT PLEASURE THIS MORNING ANNOUNCE THE BIRTH OF TWO GRANDCHILDREN LAST NIGHT. I HAVE A NEW GRANDDAUGHTER, QUINN DARBY, AND A NEW GRANDSON, DALTON MAXWELL--6 POUNDS, 11 OUNCES; 6 POUNDS, 4 OUNCES-- BORN IN NEW YORK LAST NIGHT. EVERYONE IS DOING WELL. I DIDN'T GET THE CHANCE TO TALK TO THE KIDS VERY LONG LAST NIGHT. BUT THEY DID ENCOURAGE ME TO GET SOME DOUGHNUTS, SO THEY ARE ON THE WAY. SO THIS MORNING AT SOME POINT IN TIME, WE WILL HAVE DOUGHNUTS. THANK YOU, MR. PRESIDENT.

PRESIDENT FOLEY: THANK YOU, SENATOR SCHEER, AND CONGRATULATIONS. WHILE THE LEGISLATURE IS IN SESSION AND CAPABLE OF TRANSACTING BUSINESS, I PROPOSE TO SIGN AND DO HEREBY SIGN LR404. THANK YOU. WE'LL NOW PROCEED TO THE AGENDA, CONTINUATION ON LB18. MR. CLERK. [LR404 LB18]

CLERK: MR. PRESIDENT, LB18 DISCUSSED YESTERDAY. WHEN THE LEGISLATURE LEFT THE ISSUE, SENATOR GROENE HAD PENDING AM143 AS AN AMENDMENT TO THE BILL. (LEGISLATIVE JOURNAL PAGE 477, FIRST SESSION, 2015.) [LB18]

PRESIDENT FOLEY: THANK YOU, MR. CLERK. SENATOR GROENE, YOU'RE RECOGNIZED. [LB18]

SENATOR GROENE: THANK YOU, MR. PRESIDENT. YESTERDAY, TO REMIND YOU HOW THE DEBATE WENT, I STRESSED THAT THE PUBLIC-PRIVATE COOPERATION IN A FREE SOCIETY IS WORKING ON THIS VACCINATION AND ON THIS DISEASE, MENINGOCOCCAL BACTERIAL DISEASE. FROM THE HHS DEPARTMENT STATE OF NEBRASKA, WE PASSED OUT A FORM SHOWING SINCE 2003 WHEN THEY STARTED KEEPING RECORDS BY AGE DIVISION, THERE HAS ONLY BEEN TWO CASES IN THE AGE GROUP HIGH SCHOOL...BASICALLY JUNIOR HIGH AND HIGH SCHOOL. IN THAT SAME 13-YEAR PERIOD, THERE WAS NINE IN THE COLLEGE AGE, FROM 18

TO 22. AND I REEMPHASIZE THAT WE HEARD COMPASSIONATE STORIES OF MENINGOCOCCAL BACTERIAL DISEASE OF A FOUR-YEAR-OLD AND ONE OF A 24-YEAR-OLD YOUNG ADULT. AND TO STRESS AGAIN NEITHER ONE OF THEM WOULD HAVE BEEN HELPED IF THEY WERE VACCINATED BY THIS AT THE AGE OF 12 AND AT THE AGE OR AT THE AGE OF 16. THEY'RE OUTSIDE THE RANGE OF THE EFFECTIVENESS OF THE VACCINATION. I GOT THIS SENT TO ME BY A DOCTOR. MENINGOCOCCAL BACTERIAL INFECTION HAS FALLEN TO THE LOWEST LEVEL IN MODERN HISTORY WITHOUT VACCINATION. SENATOR KUEHN MADE THE POINT ON ONE OF THE GRAPHS THAT, WELL, WE'VE HAD A VACCINATION FROM THE '90s, BUT NOT ON SEROGROUP B. SEROGROUP B HAS ALSO FALLEN TO THE LOWEST IT HAS BEEN IN HISTORY WITHOUT A VACCINATION. SOMETHING IS GOING ON IN THE CULTURE. RISK OF GETTING MENINGOCOCCAL B INFECTION OR ACWY IS ABOUT 1 IN 1,000,000. YOU HAVE A HIGHER RISK OF BEING STRUCK BY LIGHTNING, 1 IN 960,000; DYING FROM SUFFOCATION IN YOUR OWN BED, 1 IN 566,000; DYING WHILE RIDING A HORSE OR HORSE-DRAWN CARRIAGE, 1 IN 466,000; DYING FROM A MEDICAL OR SURGICAL TREATMENT, 1 IN 110,000; DYING FROM A CAR ACCIDENT AS A PASSENGER, 1 IN 17,000. THAT'S JUST THE FEARMONGERING THAT'S GOING OUT THERE ABOUT THIS VACCINATION IS NOT WARRANTED, ABOUT THE NEED FOR THIS VACCINATION--1 IN 1,000,000 CHANCE. AND REMEMBER, MOST CASES WHEN THEY ARE DIAGNOSED CORRECTLY, THE OLD-FASHIONED PENICILLIN CLEARS IT RIGHT UP. IT'S WHEN IT IS ALLOWED TO TAKE ITS COURSE IN A QUICK AMOUNT OF TIME. BUT THE SYMPTOMS SHOW UP QUICKLY. REMEMBER THAT. YOU DO NOT DIE IF YOU GET MENINGITIS...MENINGOCOCCAL BACTERIAL DISEASE. YOU CAN IF IT'S NOT TREATED. AS OF 2010, THERE REMAINS LIMITED EVIDENCE THAT ANY OF THE CURRENT CONJUGATE VACCINES OFFER CONTINUED PROTECTION BEYOND THREE YEARS. THIS IS FROM A DOCTOR WHO DEALS IN THIS SUBJECT MATTER. STUDIES ARE ONGOING TO DETERMINE THE ACTUAL DURATION OF THE IMMUNITY AND THE SUBSEQUENT REQUIREMENT OF BOOSTER VACCINATIONS. THAT STATEMENT CAME FROM THE CENTERS OF DISEASE CONTROL AND PREVENTION, CDC, JANUARY 2011. ALSO IN THE U.K.... [LB18]

SENATOR GROENE: ...IN ENGLAND BETWEEN 1997 AND 2003 THERE WERE A TOTAL OF 130 REPORTS OF FOLLOWING ALL IMMUNIZATIONS. THEY MANDATED THEIR WHOLE PUBLIC. AROUND 117 MILLION DOSES OF VACCINE WERE GIVEN. ONE IN 900,000 STILL GOT THE DISEASE. IN AMERICA IT'S 1 IN 1,000,000 WITHOUT THE MANDATE IN NEBRASKA AND 27 OTHER STATES. IT'S NOT FAIL PROOF. AS I SAID YESTERDAY, ALL VACCINATIONS ARE NOT EQUAL. YOU HAVE DIFFERENT

SUBTYPES. YOU HAVE VIRUSES. YOU HAVE BACTERIAS. AND THEY VARY ON HOW A VACCINATION WORKS AND HOW LONG IT WORKS. SO ANYWAY, I THANK YOU AND I'M GOING TO GO THROUGH THE BILL, THE ACTUAL LEGISLATION, AND DISCOUNT IT LINE BY LINE LATER IN MY TESTIMONY. THANK YOU. [LB18]

PRESIDENT FOLEY: THANK YOU, SENATOR GROENE. SENATOR KINTNER, YOU'RE RECOGNIZED. [LB18]

SENATOR KINTNER: WELL, THANK YOU, MR. PRESIDENT. I FINISHED UP THE PLEDGE, WAS WORKING ON A CUP OF COFFEE, AND THE PAGES BROUGHT AROUND AN EDITORIAL THAT WAS COPIED OFF AND SENT TO US BY ONE OF MY ESTEEMED COLLEAGUES. AND IT'S FROM THE JOURNAL STAR EDITORIAL BOARD. NOW, HERE IS A NEWS FLASH. THE LIBERALS AT THE JOURNAL STAR EDITORIAL BOARD THINK THAT WE NEED MEDICAID EXPANSION. IT STARTS OUT SAYING IT'S A SAD INDICATION OF HOW DEEP SOME IDEOLOGICAL NUTS, AKA BILL KINTNER, HAVE BECOME OPPONENTS IN TALLYING VOTES AGAINST SENATOR McCOLLISTER'S NEW HEALTHCARE PLAN BEFORE THEY EVEN KNEW WHAT IT WAS. NOW, I GOT TO TELL YOU, IF MY ESTEEMED COLLEAGUE DID NOT COPY THIS OFF TO GIVE TO YOU, I WOULD HAVE COPIED IT OFF AND GIVEN IT TO YOU BECAUSE I THINK IF A BUNCH OF LIBERALS AT THE JOURNAL STAR THINK THIS IS A GOOD IDEA AND THEY'RE THE ONES THAT THINK, YOU KNOW, GLOBAL WARMING IS ONE OF OUR MAJOR PROBLEMS, IF THEY THINK IT'S A GOOD IDEA, THIS IS PROBABLY AS GOOD A REASON AS ANY TO QUESTION IF WE NEED IT AND PROBABLY TO OPPOSE IT. SO MY GOOD COLLEAGUE FROM DISTRICT 20 JUST BEAT ME TO IT BECAUSE I WOULD HAVE COPIED THIS AND YOU WOULD HAVE HAD IT ON YOUR DESK PROBABLY A LITTLE BIT LATER TODAY, PROBABLY ABOUT THE TIME THAT THE DOUGHNUTS ARRIVED. SO I THINK THAT I WOULD ENCOURAGE YOU TO READ THEIR EDITORIAL AND DO THE EXACT OPPOSITE OF WHAT THEY WANT BECAUSE I THINK THAT'S ALWAYS GOOD PUBLIC POLICY IF YOU DO THE OPPOSITE OF WHAT THE JOURNAL STAR EDITORIAL BOARD WOULD LIKE. BACK TO THE BILL AT HAND HERE. REMEMBER WE TALKED YESTERDAY THAT WE HAVE GONE A YEAR DOWN THE ROAD THAT A YEAR AGO WHEN THIS WAS INTRODUCED IT WAS WITH THE BEST OF INTENTIONS. IT WAS TO HELP MAKE SURE THAT WE DIDN'T HAVE A PROBLEM. SO THE FIRST QUESTION WE... WITH MENINGITIS...SO THE FIRST QUESTION WE ASKED WAS, DO WE HAVE A PROBLEM WITH MENINGITIS? AND WE DIDN'T THINK WE DID. WE THOUGHT THIS WAS A LITTLE PREMATURE; THAT IT WASN'T NEEDED. SO NOW WE'RE A YEAR DOWN THE ROAD AND WE'VE HAD EXACTLY ZERO CASES OF MENINGITIS IN THE STATE OF NEBRASKA FROM KIDS IN MIDDLE SCHOOL AND HIGH SCHOOL. AS I UNDERSTAND, WE HAD ONE CASE OF A 20-YEAR-OLD STUDENT IN COLLEGE.

NOW THINK ABOUT THIS. IF THEY'RE GETTING IT IN JUNIOR HIGH AND THEY'RE GETTING IT WHEN THEY'RE 16, RIGHT WHEN THEY'RE AROUND 20, 21, IT'S WORN OFF. THE EFFECTS OF THE SHOT THAT THEY GOT IS WEARING OFF. SO EVEN IF YOU'RE 20, 21, YOU MAY BE OUTSIDE THE RANGE OF THAT LAST SHOT ANYWAY. SO THAT PERSON, EVEN IF THAT STUDENT WOULD HAVE BEEN VACCINATED, THEY MAY NOT HAVE EVEN...THAT MAY NOT EVEN HAVE HELPED THEM. SO I THINK THAT I STILL BELIEVE THIS IS NOT NEEDED. I BELIEVE IT'S WITH THE BEST OF INTENTIONS. I CAN UNDERSTAND WHY SOME PEOPLE WOULD SUPPORT IT. THEY MIGHT SAY BETTER SAFE THAN SORRY. BUT I THINK AT THE POINT WE ARE NOW IS THAT WE'VE GOT TO BE VERY CAREFUL USING THE HEAVY HAND OF GOVERNMENT TO FORCE PEOPLE TO DO THINGS. AND WHEN WE COME WITH A MANDATE THAT SAYS YOU WILL DO THIS, WE BETTER MAKE DARN SURE... [LB18]

PRESIDENT FOLEY: ONE MINUTE. [LB18]

SENATOR KINTNER: ...THAT THERE IS A PUBLIC INTEREST AT STAKE AND THERE IS NOT A BETTER WAY TO DO IT OR IF WE DIDN'T DO IT, THAT THERE IS NOT A DIRE CONSEQUENCE. AND I JUST DON'T THINK THAT THERE IS A DIRE CONSEQUENCE IF WE DO NOT DO THIS. SO I WOULD ENCOURAGE MY COLLEAGUES TO NOT SUPPORT LB18. IT'S NOT NEEDED. IT'S NOT A VOTE AGAINST ANYONE. IT'S NOT BECAUSE WE DON'T LIKE ANYONE. IT'S JUST SOMETHING THAT WE OUGHT NOT TO USE THE HEAVY HAND OF GOVERNMENT TO DO. WITH THAT, I THANK YOU, MR. PRESIDENT. [LB18]

BUT I'M STILL VERY FIRM IN MY RESOLVE THAT THIS IS A BAD IDEA. STILL TAKING THE RIGHTS OF A PARENT TO MAKE THE DECISION FOR THEIR CHILDREN IS NOT A GOOD IDEA. AND THAT'S WHAT THIS IS. YOU KNOW, WE'VE HEARD DISCUSSION OF PROTECTING THE HERD, YOU KNOW, MAKING SURE THAT EVERYBODY IS IMMUNE TO THIS SO THEY'RE NOT PASSING IT ALONG. THAT MAY HAVE SOME BENEFIT, BUT THERE IS ALSO COST INVOLVED IN WHAT WE'RE TRYING TO DO HERE. YOU KNOW, THE VACCINES ARE GETTING BETTER AND THAT'S GREAT. BUT MAKING PARENTS GIVE UP THEIR RIGHT TO DO WHAT THEY FEEL IS BEST FOR THEIR KIDS IS NOT WHAT GOVERNMENT SHOULD BE DOING. THERE IS A FINE

LINE, I'LL AGREE WITH THAT. BUT WE NEED TO HAVE PERSONAL FREEDOM IN THIS COUNTRY. AND THAT IS PERSONAL FREEDOM TO FAIL. AND THAT'S PERSONAL FREEDOM TO NOT MAKE GOOD DECISIONS ON OUR PART OR AS A PARENT, OUR KIDS. WE NEED TO MAKE SURE THAT WE DON'T CROSS THAT LINE JUST BECAUSE WE THINK THIS IS A GOOD IDEA OR THIS IS GOING TO SAVE ONE LIFE. WE CANNOT SAVE EVERYBODY. I MEAN, IT'S IMPOSSIBLE. THAT'S THE RISK YOU TAKE EVERY DAY THAT YOU'RE ALIVE. THERE ARE CHALLENGES, THERE ARE OPPORTUNITIES, AND THERE ARE RISKS THAT YOU'RE TAKING AND YOU'RE WILLING TO ASSUME THOSE RISKS. AND AS A PARENT, THAT IS YOUR JOB TO DETERMINE WHAT THE RISKS ARE, EVALUATE THE RISK-BENEFIT, AND MAKE GOOD CHOICES FOR YOUR CHILDREN. AND WHEN YOU'RE DOING THAT, YOU'RE ALSO TEACHING YOUR CHILDREN THAT THIS IS HOW PARENTING IS DONE. AND THE MORE THAT GOVERNMENT USURPS THAT AUTHORITY FROM PARENTS, THE LESS CHILDREN LEARN HOW TO BE PARENTS. AND I THINK WE'RE SEEING A LOT OF THAT IN SOCIETY TODAY, THAT GOVERNMENT IS MAKING SO MANY DECISIONS FOR THE FAMILY THAT THERE IS NO RESPONSIBILITY. AND IT'S BECOMING GENERATIONAL. THE SKILLS OF RAISING KIDS DOESN'T COME NATURALLY. YOU KNOW, YOU NEED TO LEARN THAT. YOU NEED TO BE TAUGHT THAT. YOU KNOW, THERE ARE LOTS OF BOOKS OUT THERE YOU CAN READ. SENATOR GROENE: THANK YOU, MR. PRESIDENT. THE FIRST ERROR I FIND IN THE LEGISLATION IS THIS. BUT FIRST, LET ME GO OVER SOMETHING HERE. THE SAME BILL IN THE FORM WAS INTRODUCED IN 2014 BY THE SAME INTRODUCER AND IT READ DIFFERENTLY. AND IN THE TESTIMONY AT THAT TIME--I'LL READ SOME TESTIMONY. KORBY GILBERTSON, "I AM APPEARING HERE AS A REGISTERED LOBBYIST ON BEHALF OF SANOFI PASTEUR." THAT IS THE BIG "PHARMA" COMPANY THAT MANUFACTURES THE ACWY VACCINATION. "I'M NOT REALLY AN EXPERT, BUT I HAVE DONE A LOT OF RESEARCH WHILE WORKING ON THIS LEGISLATION WITH SENATOR KRIST. AND I'D LIKE TO THANK HIM FOR ALL HIS HELP." I'M NOT CRITICIZING SENATOR KRIST. HE CARES ABOUT KIDS AND THINGS HAPPEN FAST HERE, SO YOU GO TO WHERE YOU CAN FOR HELP IN WRITING LEGISLATION. "LB460 CAME AS A RESULT...THERE ARE ACTUALLY THREE

IMMUNIZATIONS BILLS...WE'RE GENERALLY IN FRONT OF THE HEALTH COMMITTEE" INSTEAD OF THE EDUCATION COMMITTEE. "BUT BECAUSE THIS ONE HAD TO DO WITH THE IMMUNIZATIONS BEING DONE AS PART OF THE SCHOOL PROCESS, THAT'S WHY THIS BILL CAME HERE. BUT THIS BILL IS INTRODUCED BECAUSE OF THE CDC" AND WHAT THEY SAID IN 2005. WAS PRETTY MUCH WRITTEN BY SANOFI, THE ORIGINAL VERSION, WHICH ACTUALLY USED THE RIGHT TERM FOR MENINGOCOCCAL BACTERIAL DISEASE. THE PRESENT LEGISLATION SAYS: IMMUNIZATION CONTAINING...WHERE IS IT...CENTERS FOR DISEASE CONTROL AND PREVENTION RECOMMENDED MENINGITIS VACCINATIONS. THERE REALLY ISN'T SUCH A THING AS A MENINGITIS VACCINATION. THE CDC SAID THIS IN 2005: A QUADRIVALENT MENINGOCOCCAL POLYSACCHARIDE PROTEIN CONJUGATE VACCINE. MENINGITIS IS A SYMPTOM OF A LOT OF DISEASES. IT'S THE SWELLING OF THE BRAIN LINING. THERE ARE LOTS OF CAUSES OF THAT. SO WHAT ARE WE MANDATING HERE IN THIS BILL? WHICH VACCINE? IS IT FOR THE MENINGOCOCCAL BACTERIA? IS IT FOR CHILDHOOD...SOME FORMS OF LEUKEMIA THAT CAUSE MENINGITIS? THERE IS LOTS OF CAUSES OF MENINGITIS. SECONDLY, THIS BILL SAYS "ENTERING THE SEVENTH GRADE AND ENTERING THE ACADEMIC YEAR FOLLOWING ATTAINMENT OF SIXTEEN YEARS OF AGE SHALL HAVE AN IMMUNIZATION CONTAINING THE UNITED STATES CENTERS." HOW DO YOU READ THAT? SAYS "AND." SO A DOCTOR READS THAT, SCHOOL NURSE READS THAT. SENATOR GROENE: THANK YOU, SENATOR HUGHES. THANK YOU, SENATOR COASH. YEAH, SENATOR HILKEMANN ASKED SENATOR KRIST ABOUT STATES AROUND US. IOWA DOESN'T MANDATE IT. COLORADO DOESN'T MANDATE IT. IF YOU HAVE NOT DROPPED A BILL IN BY NOON TODAY WHEN WE RECESS, YOU'RE GOING TO BE OUT OF LUCK, SO JUST A REMINDER. THANK YOU.

SENATOR COASH: THANK YOU, SENATOR KRIST. SENATOR EBKE, YOU'RE RECOGNIZED. [LB18]

SENATOR EBKE: THANK YOU, MR. PRESIDENT. AND, SENATOR CHAMBERS, I WOULD NOTE THAT I DID BRING MY CHECKBOOK TODAY AND I'LL BE DELIVERING A CHECK TO YOU HERE SHORTLY. LET ME JUST RETURN US ONE MORE TIME TO THE PHILOSOPHY OF THINGS. AND I DO NOT IN ANY WAY DEMEAN SENATOR KRIST'S INTENTIONS WITH THIS BILL AND I CAN SYMPATHIZE WITH THE PURPOSE OF THE BILL. AGAIN, IT COMES DOWN TO WHAT IS IT APPROPRIATE FOR US TO TELL OTHER PEOPLE THAT THEY MUST DO. AND ABSENT A TRUE PUBLIC HEALTH NEED, I JUST HAVE A PROBLEM WITH THAT. SENATOR KUEHN: THANK YOU, MR. PRESIDENT. COLLEAGUES, MEMBERS OF THE BODY, I WOULD LIKE TO ADDRESS A FEW THINGS THIS MORNING WITH REGARD TO SOME OF THE FACTS. AND SENATOR GROENE HAS STATED THAT HE LIKES FACTS AND I TRULY BELIEVE THAT HE BELIEVES THAT HE IS STATING FACT. THERE ARE A FEW THINGS THOUGH THAT WE DO HAVE TO ADDRESS WITH REGARD TO, AGAIN, WHAT THE BILL ACTUALLY DOES STATE, AS WELL AS SOME OF THE MISREPRESENTATION OF FACTS RELATED TO THE PROCESS OF MAMMALIAN IMMUNITY, REGARDING THE PROCESS OF VACCINATION THAT HAVE BEEN PRESENTED HERE ON THE FLOOR TODAY. ANY SPECIFIC IMMUNE RESPONSE REQUIRES AN INITIAL EXPOSURE TO THE ANTIGEN TO INITIATE THE SPECIFIC IMMUNE RESPONSE WHICH THEN CREATES A MEMORY RESPONSE. UPON SECONDARY EXPOSURE TO THAT PARTICULAR ANTIGEN, THE RESPONSE IS BOTH STRONGER, AS WELL AS MORE RAPID IN DURATION, WHICH IS WHY THE PRIMING OR INITIAL DOSE CREATES MEMORY. ANYTIME THAT WE ARE UTILIZING A VACCINE OR A NONPATHOGENIC ANTIGEN, SOMETIMES WE NEED ADDITIONAL DOSES TO ESTABLISH THAT LONG-TERM MEMORY. HEPATITIS B

VIRUS TAKES THREE DIFFERENT SERIES OF VACCINES. THE POLIO, DEPENDING UPON THE NATURE OF THE VACCINE, TAKES MULTIPLE DOSES. SO THE CONCEPT THAT MORE THAN ONE DOSE IS REQUIRED IS NOT A REFLECTION OF THE INADEQUACY OF THE VACCINE, IT'S RECOGNIZING THE REALITY OF THE HUMAN IMMUNE SYSTEM, AS WELL AS THE REALITIES ASSOCIATED WITH MODERN VACCINOLOGY. I THINK WE HAVE TO BE VERY CAREFUL ABOUT LOOKING AT ANECDOTAL EVIDENCE IN A SINGLE CASE EITHER TO SWAY US ONE WAY OR ANOTHER, WHETHER THAT IS AN ANECDOTE ABOUT AN INDIVIDUAL WHO DEVELOPED THE DISEASE YEARS AFTER GRADUATING FROM COLLEGE OR THE ANECDOTE OF A SINGLE INDIVIDUAL WHO WAS A VACCINE BREAKTHROUGH OR A SINGLE INDIVIDUAL WHO WAS NEVER VACCINATED AND CONTRACTED THE DISEASE. WHAT THE CENTERS FOR DISEASE CONTROL AND THE EXPERTS THAT ARE THERE THAT UNDERSTAND THE IMMUNE SYSTEM, UNDERSTAND THE RISKS, UNDERSTAND THE COST-BENEFIT RATIO WITH A PUBLIC HEALTH TRADEOFF SUCH AS THIS, HAVE ANALYZED ALL OF THAT DATA, FREE FROM ANECDOTE, FREE FROM PREJUDICE, AND THEY HAVE ESTABLISHED A VERY CLEAR SET OF GUIDELINES. THIS LEGISLATION DOES NOT REQUIRE US AS 49 SENATORS TO UNDERSTAND THE VARIANCES OF THE IMMUNE SYSTEM OR TO PICK OR CHOOSE ONE PARTICULAR VACCINE OR SEROTYPE. THE LEGISLATION, AS PROPOSED, REQUIRES THAT WE FOLLOW THE CDC ADOPTED GUIDELINES, THE EXPERTS WHOSE JOB IT IS TO KNOW AND TO UNDERSTAND AND TO WEIGH THE RISKS WITH REGARD TO THE AVAILABLE PRODUCTS AT ANY GIVEN TIME. COMPANIES MAY PRODUCE NEW PRODUCTS WHICH ARE BETTER OR SAFER OR MORE EFFICACIOUS. THOSE WILL BE ADOPTED BY THE NEBRASKA STATUTE, AS READ, AS THOSE PRODUCTS BECOME APPROVED BY THE CDC. WHAT I DO WANT TO CALL OUT RIGHT HERE IS SOMETHING THAT WE'RE ON A VERY DANGEROUS SLOPE HERE, AND THAT IS THE RHETORIC TOWARDS CALLING INTO QUESTION THE EFFICACY OF VACCINES TAKES PLACE ON THIS FLOOR. IT CONFUSES WELL-INTENTIONED INDIVIDUALS ABOUT THE ACTUAL OUTCOME OF THEIR CHOICES. IT CLUTTERS THE ISSUE AND MAKES THEM SUSPICIOUS WHERE NO SUSPICION EXISTS. [LB18]

SENATOR KUEHN: THANK YOU, MR. PRESIDENT. WHILE IT'S VERY DIFFICULT TO GET A TRUE NUMBER ON THE PERCENTAGE OF VACCINATION BECAUSE PHYSICIANS ARE NOT REQUIRED TO REPORT TO ANY BODY THE VACCINATION WHEN IT'S GIVEN TO A PATIENT, WE DO KNOW A COUPLE OF THINGS: THAT IN MANY CASES, IN MOST CASES, AND INCLUDING WITH AVAILABLE DATA THAT WE DO HAVE NATIONWIDE WITH REGARDING MENINGITIS, VACCINATION RATES ARE
