SENATOR BRASCH: Good morning and welcome to the confirmation meeting this morning in the Transportation and Telecommunications Committee. I am Lydia Brasch of Bancroft and I am the Vice Chair of this committee presiding for Senator Jim Smith who is on the floor. To my...let's see who's here. Okay. Senator Friesen from Henderson, Senator Al Davis from Hyannis, Senator John Murante from Gretna, and on my immediate left is Mike Hybl, legal counsel to the committee and following him is Paul Henderson, the committee clerk. And seated there is J.T. Beck from Centreville, Virginia, a recent graduate. He's been with us for a while-congratulations--from UNL. And we will be conducting this hearing here.
