Conveyance Inspection Form	Sets forth the items for inspection of conveyances.

Employment Agency Renewal	Form required for renewal of Private Employment Agency License.
FARM LABOR CONTRACTORS	
Farm Labor Contractor Application	Contains the application form, instructions and notification of required attachments that must be submitted in order to apply for a Farm Labor Contractor License.
EMPLOYER REPORTING - UNEMPLOYMENT	INSURANCE RELATED
Industry Verification Form, BLS 3023-NVS	Contains a reporting form and instructions for the submission of information necessary for DOL to ensure correct classification of businesses.
Multiple Worksite Report – BLS 3020	Contains an employer reporting form and instructions for submission of required information on employer worksites, employees and wages paid.

Unemployment Insurance Letter, Intent to Intercept State Income Tax Refund	Contains notice and information regarding a debt owed to the unemployment compensation fund.
Unemployment Insurance Tax Letter 1	Contains notice and information regarding requirement to apply for an unemployment insurance tax account number.
Unemployment Insurance Tax Letter 2	Contains notice and information regarding status change affecting unemployment insurance tax account.
Unemployment Insurance Tax Letter 3	Contains notice and information regarding unemployment tax account verification.
Unemployment Insurance Tax Letter 4	Contains notice and information regarding inactivation of unemployment insurance tax account.
Unemployment Insurance Tax Letter 5	Contains notice and information regarding an individual's claim for unemployment insurance benefits when there is no record of an unemployment insurance tax account for the named business.
Unemployment Insurance Tax Letter 6	Contains notice and information regarding a change in ownership, and impact on unemployment insurance tax account.
Unemployment Insurance Tax Letter 7	Contains notice and information regarding an acquisition, and impact on unemployment insurance tax account.
Unemployment Insurance Tax Transfer Letter 1	Contains notice and information regarding transfer of an unemployment insurance account.
Unemployment Insurance Tax Transfer Letter 2	Contains notice and information regarding non-transfer of an unemployment insurance account.
Unemployment Insurance Tax Transfer Letter 3	Contains notice and information regarding non-transfer of unemployment insurance account, and notification of effective tax rate.
Unemployment Insurance Tax Transfer Letter 4	Contains notice and information regarding partial transfer of an unemployment insurance account.
Unemployment Insurance Tax Transfer Letter 5	Contains notice and information regarding partial transfer of an unemployment insurance account, including experience rating factors.
Unemployment Insurance Tax Transfer Letter 6	Contains notice and information regarding completion of transfer of unemployment insurance account, and notification of effective tax rate.
Unemployment Insurance Tax Transfer Letter 7	Contains notice and information of inactivation of unemployment insurance account, following change in ownership of business.
Unemployment Insurance Tax Transfer Letter 8	Contains notice and information for successor employers regarding application for unemployment insurance reserve balance and tax rate.
Unemployment Insurance Tax Transfer Letter 9	Contains notice and information regarding business reorganization and transfer of unemployment experience attributable to restructured portion.
