LB 1070 changes election requirements in school districts which have an average daily membership of less than 25 students in grades nine through twelve. Current law requires an annual districtwide election to continue operation of a high school with less than 25 students. The bill provides for the issue to be voted upon every four years. In the intervening years, the school board shall annually determine if such a districtwide election is necessary.

The bill has no fiscal impact for the state. There are currently two districts in operation with less than 25 students in high school according to the State Department of Education. The bill will likely result in a savings in the cost of a district-wide election in certain years for these districts, if the school board so determines.
