LB 175 is the Student Online Personal Protection Act. The bill identifies practices that are prohibited or may not be engaged in by operators of Internet web sites, online applications or services, or mobile applications which are used primarily for elementary, middle school or high school purposes. The bill also provides requirements that are to be met by operators in order to protect student information.

The bill does not identify any entity to enforce the requirements of the bill. School districts and operators of web sites and computer applications will need to structure agreements in compliance with the requirements of the bill. It is assumed contracts that adhere to the requirements of the bill can be handled with existing resources of school districts entering into such agreements.

Explanation of Estimate:

The primary focus of the bill is to establish expectations for operators of software systems in Nebraska to protect the privacy of student information.

The bill does not specifically identify what entity is responsible for carrying out or the enforcement of the provisions of the bill. The specific implementation of this law may in fact reside with the Attorney General's office and not require NDE to be involved, however schools may seek assistance from NDE should this become law. The types of support for school districts may include the evaluating service providers or operators meeting the expectations of the law, providing technical assistance for language to be implemented in terms of service agreements and other undetermined resources supporting communication and implementation.

Because of the different possibilities, at this time NDE is UNABLE TO DETERMINE the costs associated with implementation.
