This bill would change intimidation by telephone call provisions and prohibit intimidation by electronic message. Violation of the provisions of this bill is a Class III misdemeanor (Maximum — six months imprisonment, or one thousand dollars fine, or both Minimum — none).

The Supreme Court estimates no fiscal impact from this bill.

This bill appears to expand the current law. Therefore, it could impact county jails. Misdemeanor sentences are generally served in county jails if jail time is imposed. This could result in additional costs to counties.

The Lancaster County Department of Corrections states that they cannot predict how many individuals will be lodged under the provisions of this bill and therefore cannot estimate a fiscal impact.

The Lancaster County Sherrif's Office estimates no fiscal impact from this bill.

Any fines assessed pursuant to convictions will accrue to the county where the violation occurs to be used for the support of public schools.
