Business and Labor selected Senator Crawford as Vice Chair; General Affairs,

I have an Attorney General's Opinion that was delivered to the membership from the Attorney General regarding the issuance of Attorney General's Opinions. That will be inserted in the Journal. Mr. President, two motions: Senator Chambers would move to rerefer LB59 from the Health and Human Services Committee to the Judiciary Committee. He would also move to rerefer LB68 from the Government, Military and Veterans Affairs Committee to the Judiciary Committee. Those will be laid over at this time. An announcement, Mr. President. The Natural Resources Committee will have an Executive Session today at 2:00 in Room 1525; Natural Resources at 2:00 this afternoon. That's all that I have, Mr. President. PRESIDENT FOLEY: Thank you, Mr. Clerk. Speaker Scheer, you're recognized for an announcement.

SPEAKER SCHEER: Thank you, Mr. President. Colleagues, this morning we will be disseminating the calendar for this year. The calendar itself is essentially the same as was printed as a tentative calendar. No dates, no recess dates, were changed. We will continue to move forward as it was tentatively put on the Web site. There was an issue brought to my attention by one of our colleagues in relationship to starting at 9:00 this week. There was really no reason to start at 9:00 or to start at 10:00, and the senator made precise arguments that perhaps we could start later rather than earlier. Having said that, tomorrow we will start at 10:00. On Thursday we will not be able to start at 10:00. We will start at 9:30 as the Governor is giving his State of the State report on Thursday, so in order to facilitate that, we will start at 9:30 on Thursday. Friday we will start at 10:00. We will take up the adoption of the Rules Committee's report. As far as next week, we are recessed on Monday. Tuesday and Wednesday and Thursday of next week, I do not have a scheduled time you'll note on the paperwork. That really depends on how much work and how many bills...or how many rule changes we will be addressing in the time commitment that will be made there. If there are tons of work to do, then certainly we will utilize the extra hour to get through our work. If there does not seem to be much for us to do, certainly we will continue to start at 10:00. That's not a bribe, it's not a threat, it's just a utilization of time. So from that vantage point, those are the important dates. A couple of other things for your information, March 8 will be the last day to apply for a Speaker's priority bill. March 9 will be
