2 insert the following new sections:

3 Section 1. Section 28-377, Reissue Revised Statutes of Nebraska, is
4 amended to read:

5 28-377 Except as otherwise provided in sections 28-376 to 28-380, no
6 person, official, or agency shall have access to the records relating to
7 abuse unless in furtherance of purposes directly connected with the
8 administration of the Adult Protective Services Act and section 28-726.
9 Persons, officials, and agencies having access to such records shall
10 include, but not be limited to:

11 (1) A law enforcement agency investigating a report of known or
12 suspected abuse;

13 (2) A county attorney in preparation of an abuse petition;

14 (3) A physician who has before him or her a person whom he or she
15 reasonably suspects may be abused;

16 (4) An agency having the legal responsibility or authorization to
17 care for, treat, or supervise an abused vulnerable adult;

18 (5) Defense counsel in preparation of the defense of a person
19 charged with abuse;

20 (6) Any person engaged in bona fide research or auditing, except
21 that no information identifying the subjects of the report shall be made
22 available to the researcher or auditor. The researcher shall be charged
23 for any costs of such research incurred by the department at a rate
24 established by rules and regulations adopted and promulgated by the
25 department;

26 (7) The designated protection and advocacy system authorized
27 pursuant to the Developmental Disabilities Assistance and Bill of Rights

1 Act, 42 U.S.C. 6000, as the act existed on September 1, 2001, and the
2 Protection and Advocacy for Mentally Ill Individuals Act, 42 U.S.C.
3 10801, as the act existed on September 1, 2001, acting upon a complaint
4 received from or on behalf of a person with developmental disabilities or
5 mental illness; and

6 (8) ~~The For purposes of licensing providers of child care programs,~~
7 ~~the department, as required or authorized by state law, federal law,~~
8 ~~federal regulation, or applicable federal program provisions and in~~
9 ~~furtherance of its programs.~~

10 Sec. 2. Section 28-378, Reissue Revised Statutes of Nebraska, is
11 amended to read:

12 28-378 The department or appropriate law enforcement agency shall
13 provide requested information to any person legally authorized by
14 sections 28-376 to 28-380 to have access to records relating to abuse
15 when ordered by a court of competent jurisdiction or upon compliance by
16 such person with identification requirements established by rules and
17 regulations of the department or law enforcement agency. Such information
18 shall not include the name and address of the person making the report,
19 except that the department may use the name and address as required or
20 authorized by state law, federal law, federal regulation, or applicable
21 federal program provisions and in furtherance of its programs and the
22 county attorney's office may request and receive the name and address of
23 the person making the report with such person's written consent. The name
24 and other identifying data of any person requesting or receiving
25 information from the registry and the dates and the circumstances under
26 which requests are made or information is released shall be entered in
27 the registry.

29 amended to read:

30 28-716 Any person participating in an investigation or the making of
31 a report of child abuse or neglect required by section 28-711 pursuant to

1 or participating in a judicial proceeding resulting therefrom or
2 providing information or assistance, including a medical evaluation or
3 consultation in connection with an investigation, a report, or a judicial
4 proceeding pursuant to a report of child abuse or neglect, shall be
5 immune from any liability, civil or criminal, that might otherwise be
6 incurred or imposed, except for maliciously false statements.

7 Sec. 4. Section 28-719, Reissue Revised Statutes of Nebraska, is
8 amended to read:

9 28-719 Upon complying with identification requirements established
10 by regulation of the department, or when ordered by a court of competent
11 jurisdiction, any person legally authorized by section 28-722, 28-726, or
12 28-727 to have access to records relating to child abuse and neglect may
13 request and shall be immediately provided the information requested in
14 accordance with the requirements of the Child Protection and Family
15 Safety Act. Except for such information provided to department personnel
16 and county attorneys, such ~~Such~~ information shall not include the name
17 and address of the person making the report of child abuse or neglect.
18 The names and other identifying data and the dates and the circumstances
19 of any persons requesting or receiving information from the central
20 registry of child protection cases maintained pursuant to section 28-718
21 shall be entered in the central registry record.

22 Sec. 5. Section 28-726, Reissue Revised Statutes of Nebraska, is
23 amended to read:

24 28-726 Except as provided in this section and sections 28-722 and
25 81-3126, no person, official, or agency shall have access to information
26 in the tracking system of child protection cases maintained pursuant to
27 section 28-715 or in records in the central registry of child protection
28 cases maintained pursuant to section 28-718 unless in furtherance of
29 purposes directly connected with the administration of the Child
30 Protection and Family Safety Act. Such persons, officials, and agencies
31 having access to such information shall include, but not be limited to:

1 (1) A law enforcement agency investigating a report of known or
2 suspected child abuse or neglect;

3 (2) A county attorney in preparation of a child abuse or neglect
4 petition or termination of parental rights petition;

5 (3) A physician who has before him or her a child whom he or she
6 reasonably suspects may be abused or neglected;

7 (4) An agency having the legal responsibility or authorization to
8 care for, treat, or supervise an abused or neglected child or a parent, a
9 guardian, or other person responsible for the abused or neglected child's
10 welfare who is the subject of the report of child abuse or neglect;

11 (5) Any person engaged in bona fide research or auditing. No
12 information identifying the subjects of the report of child abuse or
13 neglect shall be made available to the researcher or auditor;

14 (6) The Foster Care Review Office and the designated local foster
15 care review board when the information relates to a child in a foster
16 care placement as defined in section 43-1301. The information provided to
17 the office and local board shall not include the name or identity of any
18 person making a report of suspected child abuse or neglect;

19 (7) The designated protection and advocacy system authorized
20 pursuant to the Developmental Disabilities Assistance and Bill of Rights
21 Act of 2000, 42 U.S.C. 15001, as the act existed on January 1, 2005, and
22 the Protection and Advocacy for Mentally Ill Individuals Act, 42 U.S.C.
23 10801, as the act existed on September 1, 2001, acting upon a complaint
24 received from or on behalf of a person with developmental disabilities or
25 mental illness;

26 (8) The person or persons having custody of the abused or neglected
27 child in situations of alleged out-of-home child abuse or neglect;

28 (9) The department, as required or authorized by state law, federal
29 law, federal regulation, or applicable federal program provisions and in
30 furtherance of its ~~For purposes of licensing providers of child care~~
31 ~~programs, the Department of Health and Human Services; and~~

1 (10) A probation officer administering juvenile intake services
2 pursuant to section 29-2260.01, conducting court-ordered predispositional
3 investigations prior to disposition, or supervising a juvenile upon
4 disposition; and -

5 (11) A child advocacy center pursuant to team protocols and in
6 connection with a specific case under review or investigation by a child
7 abuse and neglect investigation team or a child abuse and neglect
8 treatment team convened by a county attorney.

9 Sec. 6. Section 28-728, Reissue Revised Statutes of Nebraska, is
10 amended to read:

11 28-728 (1) The Legislature finds that child abuse and neglect are
12 community problems requiring a coordinated response by law enforcement,
13 child advocacy centers, prosecutors, the Department of Health and Human
14 Services, and other agencies or entities designed to protect children. It
15 is the intent of the Legislature to create a child abuse and neglect
16 investigation team in each county or contiguous group of counties and to
17 create a child abuse and neglect treatment team in each county or
18 contiguous group of counties.

19 (2) Each county or contiguous group of counties will be assigned by
20 the Department of Health and Human Services to a child advocacy center.
21 The purpose of a child advocacy center is to provide a child-focused
22 location for conducting forensic interviews and medical evaluations for
23 alleged child victims of abuse and neglect and for coordinating a
24 multidisciplinary team response that supports the physical, emotional,
25 and psychological needs of children who are alleged victims of abuse or
26 neglect. Each child advocacy center shall meet accreditation criteria set
27 forth by the National Children's Alliance. Nothing in this section shall
28 prevent a child from receiving treatment or other services at a child
29 advocacy center which has received or is in the process of receiving
30 accreditation.

31 (3) Each county attorney or the county attorney representing a

1 contiguous group of counties is responsible for convening the child abuse
2 and neglect investigation team and ensuring that protocols are
3 established and implemented. A representative of the child advocacy
4 center assigned to the team shall assist the county attorney in
5 facilitating case review, developing and updating protocols, and
6 arranging training opportunities for the team. Each team must have
7 protocols which, at a minimum, shall include procedures for:

8 (a) Mandatory reporting of child abuse and neglect as outlined in
9 section 28-711 to include training to professionals on identification and
10 reporting of abuse;

11 (b) Assigning roles and responsibilities between law enforcement and
12 the Department of Health and Human Services for the initial response;

13 (c) Outlining how reports will be shared between law enforcement and
14 the Department of Health and Human Services under sections 28-712.01 and
15 28-713;

16 (d) Coordinating the investigative response including, but not
17 limited to:

18 (i) Defining cases that require a priority response;

19 (ii) Contacting the reporting party;

20 (iii) Arranging for a video-recorded forensic interview at a child
21 advocacy center for children who are three to eighteen years of age and
22 are alleged to be victims of sexual abuse or serious physical abuse or
23 neglect, have witnessed a violent crime, are found in a drug-endangered
24 environment, or have been recovered from a kidnapping;

25 (iv) Assessing the need for and arranging, when indicated, a medical
26 evaluation of the alleged child victim;

27 (v) Assessing the need for and arranging, when indicated,
28 appropriate mental health services for the alleged child victim or
29 nonoffender caregiver;

30 (vi) Conducting collateral interviews with other persons with
31 information pertinent to the investigation including other potential

1 victims;

2 (vii) Collecting, processing, and preserving physical evidence
3 including photographing the crime scene as well as any physical injuries
4 as a result of the alleged child abuse and neglect; and

5 (viii) Interviewing the alleged perpetrator;

6 (e) Reducing the risk of harm to alleged child abuse and neglect
7 victims;

8 (f) Ensuring that the child is in safe surroundings, including
9 removing the perpetrator when necessary or arranging for temporary
10 custody of the child when the child is seriously endangered in his or her
11 surroundings and immediate removal appears to be necessary for the
12 child's protection as provided in section 43-248;

13 (g) Sharing of case information between team members; and

14 (h) Outlining what cases will be reviewed by the investigation team
15 including, but not limited to:

16 (i) Cases of sexual abuse, serious physical abuse and neglect, drug-
17 endangered children, and serious or ongoing domestic violence;

18 (ii) Cases determined by the Department of Health and Human Services
19 to be high or very high risk for further maltreatment; and

20 (iii) Any other case referred by a member of the team when a system-
21 response issue has been identified.

22 (4) Each county attorney or the county attorney representing a
23 contiguous group of counties is responsible for convening the child abuse
24 and neglect treatment team and ensuring that protocols are established
25 and implemented. A representative of the child advocacy center appointed
26 to the team shall assist the county attorney in facilitating case review,
27 developing and updating protocols, and arranging training opportunities
28 for the team. Each team must have protocols which, at a minimum, shall
29 include procedures for:

30 (a) Case coordination and assistance, including the location of
31 services available within the area;

1 (b) Case staffings and the coordination, development,
2 implementation, and monitoring of treatment or safety plans particularly
3 in those cases in which ongoing services are provided by the Department
4 of Health and Human Services or a contracted agency but the juvenile
5 court is not involved;

6 (c) Reducing the risk of harm to child abuse and neglect victims;

7 (d) Assisting those child abuse and neglect victims who are abused
8 and neglected by perpetrators who do not reside in their homes; and

9 (e) Working with multiproblem status offenders and delinquent youth.

10 (5) For purposes of sections 28-728 to 28-730 ~~this section~~, forensic
11 interview means a video-recorded interview of an alleged child victim
12 conducted at a child advocacy center by a professional with specialized
13 training designed to elicit details about alleged incidents of abuse or
14 neglect, and such interview may result in intervention in criminal or
15 juvenile court.

16 Sec. 7. Section 28-730, Reissue Revised Statutes of Nebraska, is
17 amended to read:

18 28-730 (1) Notwithstanding any other provision of law regarding the
19 confidentiality of records and when not prohibited by the federal Privacy
20 Act of 1974, as amended, juvenile court records and any other pertinent
21 information that may be in the possession of school districts, law
22 enforcement agencies, county attorneys, the Attorney General, the
23 Department of Health and Human Services, child advocacy centers, and
24 other team members concerning a child whose case is being investigated or
25 discussed by a child abuse and neglect investigation team or a child
26 abuse and neglect treatment team shall be shared with the respective team
27 members as part of the discussion and coordination of efforts for
28 investigative or treatment purposes. Upon request by a team, any
29 individual or agency with information or records concerning a particular
30 child shall share all relevant information or records with the team as
31 determined by the team pursuant to the appropriate team protocol. Only a

1 team which has accepted the child's case for investigation or treatment
2 shall be entitled to access to such information.

3 (2) All information acquired by a team member or other individuals
4 pursuant to protocols developed by the team shall be confidential and
5 shall not be disclosed except to the extent necessary to perform case
6 consultations, to carry out a treatment plan or recommendations, or for
7 use in a legal proceeding instituted by a county attorney or the Child
8 Protection Division of the office of the Attorney General. Information,
9 documents, or records otherwise available from the original sources shall
10 not be immune from discovery or use in any civil or criminal action
11 merely because the information, documents, or records were presented
12 during a case consultation if the testimony sought is otherwise
13 permissible and discoverable. Any person who presented information before
14 the team or who is a team member shall not be prevented from testifying
15 as to matters within the person's knowledge.

16 (3) Each team may review any case arising under the Nebraska
17 Criminal Code when a child is a victim or any case arising under the
18 Nebraska Juvenile Code. A member of a team who participates in good faith
19 in team discussion or any person who in good faith cooperates with a team
20 by providing information or records about a child whose case has been
21 accepted for investigation or treatment by a team shall be immune from
22 any civil or criminal liability. The provisions of this subsection or any
23 other section granting or allowing the grant of immunity from liability
24 shall not be extended to any person alleged to have committed an act of
25 child abuse or neglect.

26 (4) A member of a team who publicly discloses information regarding
27 a case consultation in a manner not consistent with sections 28-728 to
28 28-730 shall be guilty of a Class III misdemeanor.

29 (5) A child advocacy center shall maintain the video recording of
30 all forensic interviews conducted at that child advocacy center. Such
31 maintenance shall be in accordance with child abuse and neglect

1 investigation team protocols established pursuant to section 28-728. The
2 recording may be maintained digitally if adequate security measures are
3 in place to ensure no unauthorized access.

4 (6) Information obtained through forensic interviews may be shared
5 with members of child abuse and neglect investigation teams and child
6 abuse and neglect treatment teams.

7 (7) A custodian of a video recording of a forensic interview shall
8 not release or use the video recording or copies of such recording or
9 consent, by commission or omission, to the release or use of the video
10 recording or copies to or by any other party without a court order,
11 notwithstanding any consent or release by the child victim or child
12 witness, except that:

13 (a) The child advocacy center where a forensic interview is
14 conducted may use the video recording for purposes of supervision and
15 peer review required to meet national accreditation standards;

16 (b) Any custodian shall release or consent to the release or use of
17 the video recording upon request to law enforcement agencies authorized
18 to investigate, or agencies authorized to prosecute, any juvenile or
19 criminal conduct described in the forensic interview;

20 (c) Any custodian shall release or consent to the release or use of
21 the video recording upon request pursuant to a request under the Office
22 of Inspector General of Nebraska Child Welfare Act;

23 (d) Any custodian shall provide secure access to view a video
24 recording of a forensic interview upon request by a representative of the
25 Department of Health and Human Services for purposes of classifying cases
26 of child abuse and neglect pursuant to section 28-720 or determining the
27 risk of harm to the child and needed social services of the family
28 pursuant to section 28-713. Such representative shall be subject to the
29 same release and use restrictions as any custodian under this subsection;
30 and

31 (e) Any custodian shall release or consent to the release or use of

1 the video recording pursuant to a court order issued under section
2 29-1912 or 29-1926.

3 Sec. 8. Section 29-1926, Reissue Revised Statutes of Nebraska, is
4 amended to read:

5 29-1926 (1)(a) Upon request of the prosecuting or defense attorney
6 and upon a showing of compelling need, the court shall order the taking
7 of a video videotape deposition of a child victim of or child witness to
8 any offense punishable as a felony. The deposition ordinarily shall be in
9 lieu of courtroom or in camera testimony by the child. If the court
10 orders a video videotape deposition, the court shall:

11 (i) Designate the time and place for taking the deposition. The
12 deposition may be conducted in the courtroom, the judge's chambers, or
13 any other location suitable for video recording videotaping;

14 (ii) Assure adequate time for the defense attorney to complete
15 discovery before taking the deposition; and

16 (iii) Preside over the taking of the video videotape deposition in
17 the same manner as if the child were called as a witness for the
18 prosecution during the course of the trial.

19 (b) Unless otherwise required by the court, the deposition shall be
20 conducted in the presence of the prosecuting attorney, the defense
21 attorney, the defendant, and any other person deemed necessary by the
22 court, including the parent or guardian of the child victim or child
23 witness or a counselor or other person with whom the child is familiar.
24 Such parent, guardian, counselor, or other person shall be allowed to sit
25 with or near the child unless the court determines that such person would
26 be disruptive to the child's testimony.

27 (c) At any time subsequent to the taking of the original video
28 videotape deposition and upon sufficient cause shown, the court shall
29 order the taking of additional video videotape depositions to be admitted
30 at the time of the trial.

31 (d) If the child testifies at trial in person rather than by video

1 ~~videotape~~ deposition, the taking of the child's testimony may, upon
2 request of the prosecuting attorney and upon a showing of compelling
3 need, be conducted in camera.

4 (e) Unless otherwise required by the court, the child shall testify
5 in the presence of the prosecuting attorney, the defense attorney, the
6 defendant, and any other person deemed necessary by the court, including
7 the parent or guardian of the child victim or child witness or a
8 counselor or other person with whom the child is familiar. Such parent,
9 guardian, counselor, or other person shall be allowed to sit with or near
10 the child unless the court determines that such person would be
11 disruptive to the child's testimony. Unless waived by the defendant, all
12 persons in the room shall be visible on camera except the camera
13 operator.

14 (f) If deemed necessary to preserve the constitutionality of the
15 child's testimony, the court may direct that during the testimony the
16 child shall at all times be in a position to see the defendant live or on
17 camera.

18 (g) For purposes of this section, child means a person eleven years
19 of age or younger at the time the motion to take the deposition is made
20 or at the time of the taking of in camera testimony at trial.

21 (h) Nothing in this section shall restrict the court from conducting
22 the pretrial deposition or in camera proceedings in any manner deemed
23 likely to facilitate and preserve a child's testimony to the fullest
24 extent possible, consistent with the right to confrontation guaranteed in
25 the Sixth Amendment of the Constitution of the United States and Article
26 I, section 11, of the Nebraska Constitution. In deciding whether there is
27 a compelling need that child testimony accommodation is required by
28 pretrial video ~~videotape~~ deposition, in camera live testimony, in camera
29 video ~~videotape~~ testimony, or any other accommodation, the court shall
30 make particularized findings on the record of:

31 (i) The nature of the offense;

- 1 (ii) The significance of the child's testimony to the case;
2 (iii) The likelihood of obtaining the child's testimony without
3 modification of trial procedure or with a different modification
4 involving less substantial digression from trial procedure than the
5 modification under consideration;
6 (iv) The child's age;
7 (v) The child's psychological maturity and understanding; and
8 (vi) The nature, degree, and duration of potential injury to the
9 child from testifying.

10 (i) The court may order an independent examination by a psychologist
11 or psychiatrist if the defense attorney requests the opportunity to rebut
12 the showing of compelling need produced by the prosecuting attorney. Such
13 examination shall be conducted in the child's county of residence.

14 (j) After a finding of compelling need by the court, neither party
15 may call the child witness to testify as a live witness at the trial
16 before the jury unless that party demonstrates that the compelling need
17 no longer exists.

18 (k) Nothing in this section shall limit the right of access of the
19 media or the public to open court.

20 (l) Nothing in this section shall preclude discovery by the
21 defendant as set forth in section 29-1912.

22 (m) The Supreme Court may adopt and promulgate rules of procedure to
23 administer this section, which rules shall not be in conflict with laws
24 governing such matters.

25 (2)(a) No custodian of a video recording ~~videotape~~ of a child victim
26 or child witness alleging, explaining, denying, or describing an act of
27 sexual assault pursuant to section 28-319, 28-319.01, or 28-320.01 or
28 child abuse pursuant to section 28-707 as part of an investigation or
29 evaluation of the abuse or assault shall release or use a video recording
30 ~~videotape~~ or copies of a video recording ~~videotape~~ or consent, by
31 commission or omission, to the release or use of a video recording

1 ~~videotape~~ or copies of a video recording ~~videotape~~ to or by any other
2 party without a court order, notwithstanding the fact that the child
3 victim or child witness has consented to the release or use of the video
4 recording ~~videotape~~ or that the release or use is authorized under law,
5 except as provided in section 28-730 or pursuant to an investigation
6 under the Office of Inspector General of Nebraska Child Welfare Act. Any
7 custodian may release or consent to the release or use of a video
8 recording ~~videotape~~ or copies of a video recording ~~videotape~~ to law
9 enforcement agencies or agencies authorized to prosecute such abuse or
10 assault cases on behalf of the state.

11 (b) The court order may govern the purposes for which the video
12 recording ~~videotape~~ may be used, the reproduction of the video recording
13 ~~videotape~~, the release of the video recording ~~videotape~~ to other persons,
14 the retention and return of copies of the video recording ~~videotape~~, and
15 any other requirements reasonably necessary for the protection of the
16 privacy and best interests of the child victim or child witness.

17 ~~(c)(i) (e)~~ Pursuant to section 29-1912, the defendant described in
18 the video recording ~~videotape~~ may petition the district court in the
19 county where the alleged offense took place or where the custodian of the
20 video recording ~~videotape~~ resides for an order requiring the custodian of
21 the video recording to provide a physical copy to the defendant or the
22 defendant's attorney. Such order shall include a protective order
23 prohibiting further distribution of the video recording without a court
24 order releasing to the defendant a copy of the videotape.

25 (ii) Upon obtaining the copy of the video recording pursuant to
26 subdivision (2)(c)(i) of this section, the defendant or the defendant's
27 attorney may request that the recording be transcribed by filing a motion
28 with the court identifying the court reporter or transcriber and the
29 address or location where the transcription will occur. Upon receipt of
30 such request, the court shall enter an order authorizing the distribution
31 of a copy of the video recording to such reporter or transcriber and

1 requiring the copy of the video recording be returned by the reporter or
2 transcriber upon completion of the transcription. Such order may include
3 a protective order related to the distribution of the video recording or
4 information contained in the video recording, including an order that
5 identifying information of the child victim or child witness be redacted
6 from the transcript prepared pursuant to this subsection. Upon return of
7 such copy, the defendant or the defendant's attorney shall certify to the
8 court and the parties that such copy has been returned.

9 (iii) After obtaining the copy of the video recording pursuant to
10 subdivision (2)(c)(i) of this section, the defendant or the defendant's
11 attorney may file a motion with the court requesting permission to
12 release such copy to an expert or investigator. If the defendant or the
13 defendant's attorney believes that including the name or identifying
14 information of such expert or investigator will prejudice the defendant,
15 the court shall permit the defendant or the defendant's attorney to
16 include such information in the form of a written statement to be
17 inspected by the court alone. The statement shall be sealed and preserved
18 in the records of the court. Upon granting such motion, the court shall
19 enter an order authorizing the distribution of a copy of the video
20 recording to such expert or investigator and requiring the copy of the
21 video recording be returned by the expert or investigator upon the
22 completion of services of the expert or investigator. The order shall not
23 include the name or identifying information of the expert or
24 investigator. Such order may include a protective order related to the
25 distribution of the video recording or information contained in the video
26 recording. Upon return of such copy, the defendant or the defendant's
27 attorney shall certify to the court and the parties that such copy has
28 been returned. Such certification shall not include the name or
29 identifying information of the expert or the investigator.

30 (d) Any person who releases or uses a video recording videotape
31 except as provided in this section shall be guilty of a Class I

1 misdemeanor.

3 amended to read:

4 43-247.02 (1) Notwithstanding any other provision of Nebraska law,
5 on and after October 1, 2013, a juvenile court shall not:

6 (a) Place any juvenile adjudicated or pending adjudication under
7 subdivision (1), (2), (3)(b), or (4) of section 43-247 with the
8 Department of Health and Human Services or the Office of Juvenile
9 Services, other than as allowed under subsection (2) or (3) of this
10 section;

11 (b) Commit any juvenile adjudicated or pending adjudication under
