The Nebraska Investment Finance Authority hereby reports in accordance with the Nebraska Investment Finance Authority Act, Neb. Rev. Stat. §58-201 et seq. (Reissue 1998), as amended, to the Honorable Pete Ricketts, Governor of the State of Nebraska, and Patrick J. O'Donnell, Clerk of the Legislature on the status of the use of the proceeds of the following bonds:

(the "Bonds")

The Bonds were issued on August 7, 2019, and the total amount of bond proceeds deposited in the State Match Loan Account of the Wastewater Treatment Facilities Construction Loan Fund for the financing of loans to certain political subdivisions of the State of Nebraska was \$1,640,000.

As of December 31, 2019 \$1,640,000 has been disbursed from the State Match Loan Account as loans to Nebraska Municipalities to pay the costs of acquiring, constructing, improving, repairing, rehabilitating or extending wastewater treatment projects in accordance with Title VI of the federal Clean Water Act (the "State Revolving Fund Program"). Assuming bond proceeds are disbursed prior to other monies in the State Match Loan Account; the total funds disbursed represent 100.00% of the proceeds of the Bonds available for the financing of loans.
