LB 33A (*Kolterman*) Appropriation Bill

- LB 117 (*Hilgers*) Change provisions relating to bridge and highway construction contracts, certification of financial showing, and obtaining contract plans prepared by the Department of Transportation
- LB 79 (*Friesen*) Adopt and update references to federal transportation laws and allow for electronic images of certain registration certificates

- LB 65 (*Groene*) Authorize a licensing exception under the State Electrical Act
- LB 102 (*Wayne*) Change references from Big Twelve to Big Ten Conference in provisions requiring a stipend or restricting hours of participation for intercollegiate athletes
- LB 301 (*Lowe, at the request of the Governor*) Transfer duties under the Boiler Inspection Act, the Nebraska Amusement Ride Act, and the Conveyance Safety Act from the Department of Labor to the State Fire Marshal
- LB 359 (*Hansen, M.*) Change provisions in the Employment Security Law and Nebraska Wage Payment and Collection Act and relating to appointment of the meatpacking industry worker rights coordinator
- LB 306 (*Crawford*) Change provisions relating to good cause for voluntarily leaving employment under the Employment Security Law
