**Explanation of Estimate:** 

LB 1079 provides for the appropriation of \$250,000 in General Funds to provide funding for timely processing of sexual assault forensic evidence in accordance with national best practices.

For purposes of completing this fiscal note, the State Patrol has made the following assumptions: (1) The Nebraska State Patrol Crime Laboratory estimates that this funding would be used for two Forensic Scientist II positions, benefits, and operational costs and supplies. (2) As written, the bill does not appropriate funding for FY 2021-2022. The State Patrol has made the assumption that the appropriation for FY 2020-21 will be incorporated in the base budget for the Agency, and will continue into the next biennium. (3) The State Patrol has also made the assumption that a provision for Personal Services Limitation (PSL) will be made, so that the funds may be used for the purpose of hiring additional forensic scientists to meet the purposes specified in the bill.
