Explanation of Estimate:

LB 159 is introduced on behalf of the Department and updates the Nebraska Life and Health Insurance Guaranty Association Act to, among other things, adjust the assessment split related to long-term care insolvencies so that the assessments fall 50% to life insurers and 50% to health insurers. The bill also brings non-medicaid HMOs into the Guaranty Association. No fiscal impact on expenditures or revenues is expected as a result of LB 159.
