- 1 A BILL FOR AN ACT relating to state government; to authorize cession of
- 2 certain lands to the United States.
- 3 Be it enacted by the people of the State of Nebraska,

1 Section 1. (1) The State of Nebraska shall cede all criminal and

- 2 civil jurisdiction over and within the lands described in subsection (4)
- 3 of this section to the United States.
- 4 (2) The jurisdiction ceded by subsection (1) of this section shall
- 5 <u>be vested upon acceptance by the United States by and through its</u>
- 6 appropriate officials.
- 7 (3) The Governor is hereby authorized and empowered to execute all
- 8 proper conveyances necessary to grant the cession provided in this
- 9 section upon request of the United States by its appropriate officials.
- 10 (4) This section applies to the following described real estate
- 11 <u>located in Sarpy County, Nebraska:</u>
- 12 <u>(a) Tract number 58: A tract of land situated in the southwest</u>
- 13 quarter of section 35, township 14 north, range 13 east of the sixth
- 14 principal meridian, Sarpy County, Nebraska, the boundary of which is
- 15 <u>described as follows; Beginning at a point on the south line of said</u>
- 16 section 35, said point being 486.75 feet east of the southwest corner of
- 17 said section 35, thence north 275.9 feet, thence east 211.2 feet, thence
- 18 south 66 feet, thence west 2.48 feet, thence south 209.9 feet to the
- 19 south line of said section 35, thence west along the south line of said
- 20 <u>section 35 a distance of 208.72 feet to the point of beginning. The tract</u>
- 21 of land herein described contains 1.32 acres, more or less;
- 22 (b) Tract number 240: All that portion of The Burlington Northern
- 23 and Santa Fe Railway Company's (formerly Chicago, Burlington & Quincy
- 24 Railroad Company) Pappio to Gilmore Jct., Nebraska Branch Line right-of-
- 25 way, now discontinued, varying in width on each side of said Railway
- 26 Company's Main Track centerline as originally located and constructed
- 27 upon, over, and across the southwest quarter of the northwest quarter,
- 28 the north half of the northwest quarter of the southwest quarter, the
- 29 northeast quarter of the southwest quarter, and the north half of the
- 30 southeast quarter (later platted as a part of Palmtag's Subdivision)
- 31 <u>section 11, township 13 north, range 13 east of the sixth principal</u>

meridian, Sarpy County, Nebraska, extending from Station 185+38 (MP 4.94) 1 2 on the westerly right-of-way line of an existing public road to Station 3 151+04 on the easterly right-of-way line of Highway 75 as shown in quit 4 claim deed filed January 11, 1990, instrument number 90-00655 and being 5 more particularly described as follows: Commencing at the west quarter corner of said section 11; thence north 02 degrees, 38 minutes, 08 6 7 seconds west along the west line of said section 11, a distance of 899.52 feet; thence northeasterly along the existing easterly right-of-way line 8 9 of said Highway 75, deflecting 59 degrees, 24 minutes, 24 seconds right, 10 49.54 feet; thence southeasterly along said existing easterly right-ofway line of Highway 75, along a curve to the left having a radius of 11 1,659.93 feet, deflection to the initial tangent being 90 degrees, 00 12 13 minutes, 00 seconds right, subtending a central angle of 15 degrees, 16 minutes, 17 seconds, for a distance of 442.43 feet; thence southwesterly 14 15 along said existing easterly right-of-way line of Highway 75, deflecting 16 90 degrees, 00 minutes, 00 seconds left, 166.00 feet to Offutt Boundary 17 Marker 88-20; thence southeasterly along said existing easterly right-ofway line of Highway 75, along a curve to the left, having a radius of 1, 18 19 825.93 feet, deflection to the initial tangent being 90 degrees, 00 minutes, 00 seconds left, subtending a central angle of 00 degrees, 30 20 21 minutes, 23 seconds, for a distance of 16.14 feet; thence southerly along 22 said existing easterly right-of-way line of Highway 75, along a curve to 23 the left having a radius of 3,164.04 feet, deflection to the initial 24 tangent being 62 degrees, 36 minutes, 54 seconds right, subtending a central angle of 02 degrees, 32 minutes, 39 seconds, 140.49 feet to the 25 northeasterly right-of-way line of the Union Pacific Railroad (formerly 26 27 Missouri Pacific Railroad) and being the point of beginning; thence 28 northerly along the last described course, 140.49 feet to the northerly right-of-way line of said abandoned Burlington Northern and Santa Fe 29 30 Railway; thence southeasterly along said northerly right-of-way line of the abandoned railroad, along a curve to the left having a radius of 1, 31

859.17 feet for an arc length of 903.19 feet, more or less, to the north 1 2 line of said north half of the northwest quarter of the southwest quarter (Offutt Boundary Marker 88-19); thence north 87 degrees, 40 minutes, 01 3 4 seconds east along said northerly right-of-way line and along said north 5 line of the north half of the northwest quarter of the southwest quarter, a distance of 276.79 feet, more or less, to the northeast corner thereof 6 7 (Offutt Boundary Marker 88-18); thence south 05 degrees, 27 minutes, 27 seconds west along said northerly right-of-way line and along the east 8 9 line of said north half of the northwest quarter of the southwest quarter, a distance of 58.57 feet, more or less, to Offutt Boundary 10 Marker 88-17; thence south 84 degrees, 32 minutes, 33 seconds east along 11 said northerly right-of-way line, 1,818.10 feet to Offutt Boundary Marker 12 13 88-16; thence north 05 degrees, 27 minutes, 27 seconds east along said 14 northerly right-of-way line, 25.00 feet to Offutt Boundary Marker 88-15; thence south 84 degrees, 32 minutes, 33 seconds east along said northerly 15 16 right-of-way line, 181.80 feet to Offutt Boundary Marker 88-14; thence 17 southeasterly along said northerly right-of-way line along a curve to the right having a radius of 1,712.04 feet for an arc length of 389.57 feet 18 19 (the chord bears south 78 degrees, 01 minutes, 26 seconds east, 388.73 feet) to the westerly right-of-way line of an existing county road; 20 thence south 18 degrees, 29 minutes, 42 seconds west along said westerly 21 right-of-way line, 75.00 feet to Station 185+38 (M.P. 4.94) on the 22 centerline of said abandoned railroad; thence continuing south 18 23 24 degrees, 29 minutes, 42 seconds west along said westerly right-of-way 25 line, 75.00 feet to the southerly right-of-way line of said abandoned railroad; thence northwesterly along said southerly right-of-way line 26 27 along a curve to the left having a radius of 1,562.04 feet for an arc 28 length of 357.28 feet, more or less, to a point, said point being 75.00 feet southwesterly of and at right angles to said centerline at Station 29 181+96; thence north 84 degrees, 32 minutes, 33 seconds west along said 30 31 southerly right-of-way line to the intersection with the centerline of

the old channel (about year 1900) of Papillion Creek; thence 1 2 southeasterly along said centerline of the old channel and being the 3 southerly right-of-way line of the said abandoned railroad to a point 4 250.00 feet southerly of, measured at right angles to said centerline of 5 the abandoned railroad; thence north 84 degrees, 32 minutes, 33 seconds west along said southerly right-of-way line, 1,880.00 feet, more or less, 6 7 to a point, said point being 250.00 feet southwesterly of and at right angles to said centerline of the abandoned railroad at Station 162+26; 8 9 thence northwesterly along a curve to the right having a radius of 2, 10 159.17 feet for an arc length of 566.00 feet, more or less, to the intersection of said southerly right-of-way line with said northeasterly 11 right-of-way line of Union Pacific Railroad (formerly the Missouri 12 13 Pacific Railroad); thence northwesterly along said northeasterly rightof-way line to the point of beginning; 14 (c) Tract number 227: A tract of land situated in the south half of 15 16 section 35, township 14 north, range 13 east of the sixth principal 17 meridian, Sarpy County, Nebraska, more particularly described as follows: Beginning at the point where the easterly right-of-way line of State 18 19 Highway 73-75 intersects the south line of said section 35; thence north along said easterly right-of-way line of State Highway 73-75, a distance 20 21 of 610.00 feet; thence southeasterly a distance of 2,365.00 feet to a point on said south line of section 35, said point being 2,285.00 feet 22 easterly from said point of intersection of said south line with said 23 24 easterly right-of-way line of State Highway 73-75 and also being a point 25 on the northeasterly right-of-way line of Nelson Drive, state-owned, hard-surfaced four-lane highway; thence westerly along aforesaid south 26 27 line, section 35 to the southwesterly right-of-way line of said Nelson Drive; thence northwesterly, along aforesaid westerly right-of-way line, 28 a distance of 640.00 feet; thence southwesterly, at right angles, to the 29 left a distance of 60.00 feet; thence southeasterly, a distance of 360.00 30

feet, to a point on said south line, said point being 300.00 feet

- 1 westerly from said southwesterly right-of-way line of Nelson Drive;
- 2 thence westerly, along said south line, to the point of beginning.
- 3 Excepting therefrom, a tract of land situated in said south half of
- 4 section 35, more particularly described as follows: Beginning at a point
- 5 on the south line of said section 35, said point being 486.75 feet east
- 6 of the southwest corner thereof; thence north 275.9 feet; thence east
- 7 211.2 feet; thence south 66.00 feet; thence west 2.48 feet; thence south
- 8 209.9 feet to said south line; thence west along said south line a
- 9 distance of 208.72 feet to the point of beginning. The tract of land
- 10 <u>herein described contains 13.60 acres, more or less;</u>
- 11 (d) Tract number 228: A tract of land, situated in the south half of
- 12 <u>section 35, township 14 north, range 13 east of the sixth principal</u>
- meridian, Sarpy County, Nebraska, more particularly described as follows:
- 14 Commencing at the southwest corner of said section 35, thence easterly,
- 15 along the south line of said south half, a distance of 523.00 feet to the
- 16 easterly right-of-way line of the U.S. Highway 73 and 75; thence
- 17 northerly, along said easterly right-of-way of said highway, a distance
- 18 of 610.00 feet to the point of beginning of said tract of land to be
- 19 described; thence southeasterly, a distance of 2,365.00 feet to a point
- 20 on said line of south half, said point being 2,285.00 feet easterly from
- 21 said point of intersection of said south line with said easterly right-
- 22 of-way line of state highway 73-75, and also being a point on the
- 23 northerly right-of-way line of Nelson Drive, state-owned, hard-surfaced
- 24 <u>four-lane highway; thence northwesterly, along aforesaid northerly right-</u>
- 25 of-way line of said Nelson Drive, to the centerline of existing drainage
- 26 <u>ditch; thence southwesterly, along the centerline of aforesaid drainage</u>
- 27 <u>ditch, to said easterly right-of-way line of State Highway 73 and 75;</u>
- 28 thence southerly along aforesaid easterly right-of-way line of State
- 29 Highway 73 and 75, to the point of beginning. The tract of land herein
- 30 <u>described contains 4.30 acres, more or less; and</u>
- 31 (e) Tract number 229: A tract of land situated in tax lot 11a and

tax lot 11b, which are a part of the south half of section 35, township 1 2 14 north, range 13 east of the sixth principal meridian, Sarpy County, 3 Nebraska, more particularly described as follows: Commencing at the south 4 quarter corner of said section 35; which is also the southwest corner of 5 said tax lot 11b; thence easterly along the south line of said section 35, which also is the south line of said tax lot 11b, a distance of 6 7 445.50 feet to the southeast corner of said tax lot 11b which is also the point of beginning of said tract of land to be described; thence 8 9 northerly along the east line of said tax lot 11b, a distance of 1,081.40 10 feet; thence westerly at right angles to the left a distance of 170.00 feet; thence southerly at right angles to the left a distance of 33.00 11 12 feet; thence westerly at right angles to the right a distance of 590.00 feet; thence northerly at right angles to the right to a point said point 13 being more particularly described as follows: Commencing at said 14 15 southwest corner of said tax lot 11b; thence northerly along the west line of said tax lot 11b, which is also the north-south centerline of 16 17 said section 35, a distance of 1,083.81 feet; thence westerly at right angles to the left a distance of 315.40 feet to said point being 18 19 described; thence north 76 degrees, 01 minutes, 00 seconds west a distance of 258.17 feet; thence north 24 degrees, 50 minutes, 00 seconds 20 east a distance of 11.95 feet; thence north 65 degrees, 10 minutes, 00 21 22 seconds west a distance of 235.27 feet; thence north a distance of 39.16 feet to a point on the easterly line of Martinview Addition in said Sarpy 23 24 County, as platted and recorded; thence southwesterly along a curve to 25 the right having a radius of 284.50 feet, for an arc length of 446.90 feet, said curve being the southeasterly line of Martinview Addition; 26 27 thence south 89 degrees, 46 minutes, 05 seconds west along the southerly 28 line of said Martinview Addition a distance of 161.04 feet; thence south 89 degrees, 41 minutes, 55 seconds west along aforesaid southerly line of 29 30 Martinview Addition, a distance of 391.56 feet; thence south 83 degrees, 34 minutes, 10 seconds west a distance of 134.92 feet; thence south 72 31

1 degrees, 28 minutes, 10 seconds west a distance of 128.74 feet; thence

- 2 south 82 degrees, 39 minutes, 10 seconds west to the northeasterly right-
- 3 of-way line of state-owned four-lane highway, known as Nelson Drive;
- 4 thence southeasterly along the aforesaid northeasterly right-of-way line
- 5 of Nelson Drive; to a point on said south line of tax lot 11b; thence
- 6 easterly along said south line a distance of 282.50 feet to the point of
- 7 <u>beginning</u>. The tract of land herein described contains 40.51 acres, more
- 8 <u>or less.</u>
