- 1 A BILL FOR AN ACT relating to building codes; to amend sections 71-6404
- 2 and 71-6406, Reissue Revised Statutes of Nebraska; to change
- 3 provisions relating to local building and construction codes; to
- 4 harmonize provisions; and to repeal the original sections.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 71-6404, Reissue Revised Statutes of Nebraska, is
2 amended to read:

3 71-6404 (1) For purposes of the Building Construction Act, component
4 means a portion of the state building code adopted by reference pursuant
5 to section 71-6403.

6 (2) The state building code shall be the building and construction
7 standard within the state and shall be applicable:

8 (a) To all buildings and structures owned by the state or any state
9 agency; ~~and~~

10 (b) In each county, city, or village which elects to adopt the state
11 building code as its local building or construction code pursuant to
12 section 71-6406; and ~~or any component or combination of components of the~~
13 ~~state building code.~~

14 (c) In each county, city, or village which has not adopted a local
15 building or construction code pursuant to section 71-6406 within two
16 years after an update to the state building code.

17 Sec. 2. Section 71-6406, Reissue Revised Statutes of Nebraska, is
18 amended to read:

19 71-6406 (1)(a) ~~(1)~~ Any county, city, or village may enact,
20 administer, or enforce a local building or construction code if or as
21 long as such county, city, or village:

22 (i) ~~(a)~~ Adopts the state building code; or

23 (ii) ~~(b)~~ Adopts a building or construction code that conforms
24 generally with the state building code.

25 (b) If a county, city, or village does not adopt a code as
26 authorized under subdivision (a) of this subsection within two years
27 after an update to the state building code, the state building code shall
28 apply in the county, city, or village, except that such code shall not
29 apply to construction on a farm or for farm purposes.

30 (2) A local building or construction code shall be deemed to conform
31 generally with the state building code if it:

1 (a) Adopts a special or differing building standard by amending,
2 modifying, or deleting any portion of the state building code in order to
3 reduce unnecessary costs of construction, increase safety, durability, or
4 efficiency, establish best building or construction practices within the
5 county, city, or village, or address special local conditions within the
6 county, city, or village;

7 (b) Adopts any supplement, new edition, appendix, or component or
8 combination of components of the state building code;

9 (c) Adopts section 305 of the 2012 edition of the International
10 Building Code without the exceptions described in subdivision (1)(a) of
11 section 71-6403, chapter 13 of the 2012 edition of the International
12 Building Code, chapter 11 of the 2012 edition of the International
13 Residential Code, or section R313 of the 2012 edition of the
14 International Residential Code;

15 (d) Adopts a plumbing code, an electrical code, a fire prevention
16 code, or any other standard code as authorized under section 14-419,
17 15-905, 18-132, or 23-172; or

18 (e) Adopts a lighting and thermal efficiency ordinance, resolution,
19 code, or standard as authorized under section 81-1618.

20 (3) A local building or construction code which includes a prior
21 edition of any component or combination of components of the state
22 building code shall not be deemed to conform generally with the state
23 building code.

24 (4) A county, city, or village shall not adopt or enforce a local
25 building or construction code other than as provided by this section.

26 (5) A county, city, or village which adopts or enforces a local
27 building or construction code under this section shall regularly update
28 its code. For purposes of this section, a code shall be deemed to be
29 regularly updated if the most recently enacted state building code or a
30 code that conforms generally with the state building code is adopted by
31 the county, city, or village within two years after an update to the

1 state building code.

2 (6) A county, city, or village may adopt amendments for the proper
3 administration and enforcement of its local building or construction code
4 including organization of enforcement, qualifications of staff members,
5 examination of plans, inspections, appeals, permits, and fees. Any
6 amendment adopted pursuant to this section shall be published separately
7 from the local building or construction code.

8 (7) A county, city, or village which adopts one or more standard
9 codes as part of its local building or construction code under this
10 section shall keep at least one copy of each adopted code, or portion
11 thereof, for use and examination by the public in the office of the clerk
12 of the county, city, or village prior to the adoption of the code and as
13 long as such code is in effect.

14 (8) Notwithstanding the provisions of the Building Construction Act,
15 a public building of any political subdivision shall be built in
16 accordance with the applicable local building or construction code. Fees,
17 if any, for services which monitor a builder's application of codes shall
18 be negotiable between the political subdivisions involved, but such fees
19 shall not exceed the actual expenses incurred by the county, city, or
20 village doing the monitoring.
