- 1 A BILL FOR AN ACT relating to the University of Nebraska; to amend
- 2 section 49-506, Revised Statutes Supplement, 2019; to change the
- 3 distribution of session laws and legislative journals to the College
- 4 of Law; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 49-506, Revised Statutes Supplement, 2019, is
2 amended to read:

3 49-506 After the Secretary of State has made the distribution
4 provided by section 49-503, he or she shall deliver additional copies of
5 the session laws and the journal of the Legislature pursuant to this
6 section in print or electronic format as he or she determines, upon
7 recommendation by the Clerk of the Legislature and approval of the
8 Executive Board of the Legislative Council.

9 One copy of the session laws shall be delivered to the Lieutenant
10 Governor, the State Treasurer, the Auditor of Public Accounts, the
11 Reporter of the Supreme Court and Court of Appeals, the State Court
12 Administrator, the State Fire Marshal, the Department of Administrative
13 Services, the Department of Agriculture, the Department of Banking and
14 Finance, the State Department of Education, the Department of Environment
15 and Energy, the Department of Insurance, the Department of Labor, the
16 Department of Motor Vehicles, the Department of Revenue, the Department
17 of Transportation, the Department of Veterans' Affairs, the Department of
18 Natural Resources, the Military Department, the Nebraska State Patrol,
19 the Nebraska Commission on Law Enforcement and Criminal Justice, each of
20 the Nebraska state colleges, the Game and Parks Commission, the Nebraska
21 Library Commission, the Nebraska Liquor Control Commission, the Nebraska
22 Accountability and Disclosure Commission, the Public Service Commission,
23 the State Real Estate Commission, the Nebraska State Historical Society,
24 the Public Employees Retirement Board, the Risk Manager, the Legislative
25 Fiscal Analyst, the Public Counsel, the materiel division of the
26 Department of Administrative Services, the State Records Administrator,
27 the budget division of the Department of Administrative Services, the Tax
28 Equalization and Review Commission, the inmate library at all state penal
29 and correctional institutions, the Commission on Public Advocacy, and the
30 Library of Congress; two copies to the Governor, the Secretary of State,
31 the Nebraska Workers' Compensation Court, the Commission of Industrial

1 Relations, and the Coordinating Commission for Postsecondary Education,
2 one of which shall be for use by the community colleges; three copies to
3 the Department of Health and Human Services; four copies to the Nebraska
4 Publications Clearinghouse; five copies to the Attorney General; nine
5 copies to the Revisor of Statutes; fifteen copies to the University of
6 Nebraska College of Law; and sixteen copies to the Supreme Court and the
7 Legislative Council; ~~and thirty-five copies to the University of Nebraska~~
8 ~~College of Law.~~

9 One copy of the journal of the Legislature shall be delivered to the
10 Governor, the Lieutenant Governor, the State Treasurer, the Auditor of
11 Public Accounts, the Reporter of the Supreme Court and Court of Appeals,
12 the State Court Administrator, the Nebraska State Historical Society, the
13 Legislative Fiscal Analyst, the Tax Equalization and Review Commission,
14 the Commission on Public Advocacy, and the Library of Congress; two
15 copies to the Secretary of State, the Commission of Industrial Relations,
16 and the Nebraska Workers' Compensation Court; four copies to the Nebraska
17 Publications Clearinghouse; five copies to the Attorney General and the
18 Revisor of Statutes; eight copies to the Clerk of the Legislature; ten
19 copies to the University of Nebraska College of Law; and thirteen copies
20 to the Supreme Court and the Legislative Council; ~~and thirty-five copies~~
21 ~~to the University of Nebraska College of Law.~~ The remaining copies shall
22 be delivered to the State Librarian who shall use the same, so far as
23 required for exchange purposes, in building up the State Library and in
24 the manner specified in sections 49-507 to 49-509.
