Mr. O'Donnell,

Nebraska Statute 83-4,134.01 requires Nebraska's juvenile facilities to report quarterly to the Legislature and the Office of the Inspector General, information regarding the use of room confinement in Nebraska's juvenile facilities.

Attached you will find the room confinement usage data for the Youth Rehabilitation and Treatment Center (YRTC) in Kearney, the YRTC in Hastings, the YRTC in Lincoln, and the Whitehall Psychiatric Residential Treatment Facility in Lincoln for the first quarter of fiscal year 2022-2023. All facilities followed Center for Disease Control and local public health department recommendations on the use of medical quarantine for youth testing positive or exposed to COIVD-19. Youth entering the facilities were also placed in quarantine until they could be tested for COVID-19.

The YRTC system continues to use room confinement as a behavioral management tool for the high risk youth in our care. Efforts are continually being made to ensure that youth are only in confinement for the shortest amount of time possible to ensure their safety and the safety of the other youth and staff around them.
