Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 1205 creates the Ernie Chambers History-Arts-Humanities Museum Assistance Fund. The fund shall be used to contribute to the construction of a museum with the same name.

The Nebraska State Historical Society (NSHS) shall administer the fund, which shall consist of transfers authorized by the Legislature, and any gifts, grants, or bequests from any source.

No later than December 31, 2022, the NSHS shall execute a memorandum of understanding with an organization that is incorporated in Nebraska and exempt for federal tax purposes under section 501(c)(3) of the Internal Revenue Code. The memorandum of understanding shall include detailed plans by the NSHS to develop and construct the museum.

The NSHS estimates the cost to develop detailed plans to be \$131,023. This estimate is based on a similar project in 2020.

There is no basis to disagree with this estimate.

Explanation of Estimate:

LB1205 requires the agency to develop "detailed plans" to "develop and construct the Ernie Chambers History-Arts-Humanities Museum". The cost for plan development included in this fiscal note is based on the renovation of the Chimney Rock National Historic Site Visitor Center in 2020, adjusted 3% annually for inflation. These are costs for planning only. LB1204 is silent on who will operate the museum or acquire the property. The fiscal impact will be greater if the Nebraska State Historical Society is expected to acquire property for development, design and construct exhibitions, or staff the museum.
