Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 224 seeks to make small changes relating to the selection of a county surveyor. Specifically, for counties containing less than 150,000 people, when the electorate has voted in opposition of a county surveyor, or where no surveyor has been elected, the county board shall appoint a county surveyor. Under LB 224, the county board must select a registered land surveyor. Prior this, the language for the section only requires the surveyor to be competent. Other language is simplified to reduce redundancy.

The Nebraska State Surveyor estimates no fiscal impact as a result of LB 224. There is no basis to disagree with this estimate.

The impact to political subdivisions is unlikely to be significant. The only circumstance where this language change would be relevant would be a case where a county moves to appoint an unregistered land surveyor, which seems improbable, given that a competent land surveyor would need to already have been registered to survey land in Nebraska.

LB 224 would become operative January 1, 2022.
