LB840 amends §25-2228 and §33-141 to change the provisions relating to publication and rates.

Beginning October 1, 2022, the legal rates for the publication will change and all legal publications and notices of any kind or character that may by law be required to be published for a certain number of days or a certain number of weeks will also be posted by the publishing newspaper on a statewide website established and maintained as storage for such notices by a majority of Nebraska newspapers.

EXPENDITURES:

The Nebraska Supreme Court estimates minimal impact to the state, all of which can be absorbed with current funding.

Douglas County estimates an increase in costs of 6-7% for FY2022-23 and a 4-5% increase for FY2023-24 resulting in approximately a 10-11% overall increase to their current budgeted amount. Douglas County estimates those increased costs would be \$700-900 per year.

Lancaster County estimates an increase in their costs to be \$500 per year.
