LB 886 would prohibit the use of restraints on the abdomen, wrists or chest on any pregnant prisoner or detainee. The bill further would permit a prisoner or detainee to have at least one support person for accompaniment during labor and delivery and, if available, a doula, midwife or other birthing specialist may also assist during labor and delivery.

The Lancaster County Department of Corrections report an average of four in-custody births per year. Due to the differences in the costs of doulas and midwifes and the potential need for additional staff to maintain security, it is difficult to ascertain the fiscal impact.

The Nebraska Department of Correctional Services does not anticipate any fiscal impact.
