LB 949 amends provisions related to the statement of property taxes. For all counties not containing a city of the metropolitan class, LB 949 requires that the statement of taxes provided include the following language: "Please check with the county to determine if special assessments are due."

LB 949 does not have a fiscal impact to the state, but there could be some costs to counties. The Nebraska Association of County Officials estimates minimal costs to counties, including some computer programming costs. The Lancaster County Treasurer estimates no fiscal impact.
