Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 967 allows the Workers' Compensation Court to publish notices of public hearings on its official website in lieu of publishing in a newspaper having a general circulation in the state. The elimination of the need to publish in a newspaper could save the Court approximately \$900 to \$1,500 per year [see page 2, lines 12-15.] The court already conducts certain hearings and trials via videoconference. To the extent LB 967 broadens the ability of the court to conduct hearings and trials via videoconference, it is likely to eliminate some of the travel expenses incurred by the judges who serve on the court. [page 3, lines 17-25.]
