1 A BILL FOR AN ACT relating to retirement; to amend sections 23-2317.01,
2 79-920, 84-1319.01, and 84-1511, Reissue Revised Statutes of
3 Nebraska, sections 23-2309.01, 23-2310.05, 72-1243, 79-921, 84-1301,
4 84-1310.01, 84-1311.03, and 84-1322, Revised Statutes Cumulative
5 Supplement, 2020, and sections 79-902, 79-978, 79-992.01, 79-9,117,
6 and 84-1503, Revised Statutes Supplement, 2021; to eliminate
7 obsolete provisions relating to investment options under certain
8 acts, the state investment officer, and the Public Employees
9 Retirement Board; to change provisions relating to certain funds; to
10 define and redefine terms; to change provisions relating to
11 participation in certain plans as prescribed; to eliminate
12 provisions relating to termination of employment and early
13 retirement inducement notification; to change duties of certain
14 employers; to change provisions relating to preretirement planning
15 and repayment of a distribution after reemployment; to change duties
16 of and provide duties for the Public Employees Retirement Board; to
17 provide a deadline for a certain compliance audit; to provide for
18 retirement training sessions; to eliminate a retirement education
19 and financial planning program; to harmonize provisions; to repeal
20 the original sections; to outright repeal section 84-1511.01,
21 Reissue Revised Statutes of Nebraska; and to declare an emergency.
22 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 23-2309.01, Revised Statutes Cumulative
2 Supplement, 2020, is amended to read:

3 23-2309.01 (1)(a) ~~(1)~~ Each member employed and participating in the
4 retirement system prior to January 1, 2003, who has elected not to
5 participate in the cash balance benefit, shall be allowed to allocate all
6 contributions to the member's ~~his or her~~ employee account to various
7 investment options. The investment options shall include, but not be
8 limited to, the following:

9 ~~(a) Prior to January 1, 2021, the investment options shall include,~~

11 ~~(i) An investor select account which shall be invested under the~~

12 subdivision ~~(a)(v) (b)(v)~~ of this subsection. Each member shall be given
13 a detailed current description of each investment option prior to making
14 or revising ~~the member's his or her~~ allocation.

15 (2) Members of the retirement system may allocate their
16 contributions to the investment options in percentage increments as set
17 by the board in any proportion, including full allocation to any one
18 option. A member under subdivision (1)(a) of section 23-2321 or ~~the~~
19 ~~member's his or her~~ beneficiary may transfer any portion of ~~the member's~~
20 ~~his or her~~ funds among the options, except for restrictions on transfers
21 to or from the stable return account pursuant to rule or regulation. The
22 board may adopt and promulgate rules and regulations for changes of a
23 member's allocation of contributions to ~~the member's his or her~~ accounts
24 after ~~the member's his or her~~ most recent allocation and for transfers
25 from one investment account to another.

26 (3) The board shall develop a schedule for the allocation of
27 administrative costs of maintaining the various investment options and
28 shall assess the costs so that each member pays a reasonable fee as

31 administrative services agreements for accounting or record-keeping

1 services. No agreement shall be entered into unless the board determines
2 that it will result in administrative economy and will be in the best

5 of the Nebraska Investment Council, or the county shall not be liable for
6 any investment results resulting from the member's exercise of control
7 over the assets in the employee account.

9 2020, is amended to read:

10 23-2310.05 (1) Each member employed and participating in the
11 retirement system prior to January 1, 2003, who has elected not to
12 participate in the cash balance benefit, shall be allowed to allocate all
13 contributions to the member's ~~his or her~~ employer account to various
14 investment options. Such investment options shall be the same as the
15 investment options of the employee account as provided in subsection (1)
16 of section 23-2309.01. If a member fails to select an option or
17 combination of options, all of the member's ~~his or her~~ funds in the
18 employer account shall be placed in the investment option described in
19 subdivision (1)(a)(v) ~~or (1)(b)(v)~~ of section 23-2309.01, ~~whichever~~
20 ~~option is applicable based on the date of contribution.~~ Each member shall

16 amended to read:

17 23-2317.01 ~~The~~ There is hereby created the County Equal Retirement
18 Benefit Fund is created. The fund shall ~~to~~ be administered by the board.
19 Each county participating in the retirement system on January 1, 1984,
20 pursuant to the County Employees Retirement Act shall make a contribution
21 at least once a year to the fund, in addition to any other retirement
22 contributions. Such contribution shall be in an amount determined by the
23 board to provide all similarly situated male and female members of the
24 retirement system with equal benefits pursuant to subsection (2) of
25 section 23-2317 and to provide for direct expenses incurred in
26 administering the fund. The board shall keep a record of the
27 contributions made by each county. Any money in the fund available for
28 investment shall be invested by the state investment officer pursuant to
29 the Nebraska Capital Expansion Act and the Nebraska State Funds
30 Investment Act.

31 Sec. 4. Section 72-1243, Revised Statutes Cumulative Supplement,

1 2020, is amended to read:

2 72-1243 (1) Except as otherwise specifically provided by law, the
3 state investment officer shall direct the investment and reinvestment of
4 money in all state funds not currently needed and all funds described in
5 section 83-133 and order the purchase, sale, or exchange of securities
6 for such funds. He or she shall notify the State Treasurer of any
7 payment, receipt, or delivery that may be required as a result of any
8 investment decision, which notification shall be the authorization and
9 direction for the State Treasurer to make such disbursement, receipt, or
10 delivery from the appropriate fund.

11 (2) The council shall have an analysis made of the investment
12 returns that have been achieved on the assets of each retirement system
13 administered by the Public Employees Retirement Board as provided in
14 section 84-1503 and, ~~beginning January 1, 2017,~~ on the assets of each
15 retirement system provided for under the Class V School Employees
16 Retirement Act. By March 31 of each year, the analysis shall be presented
17 to the board and the Nebraska Retirement Systems Committee of the
18 Legislature. The analysis shall be prepared by an independent
19 organization which has demonstrated expertise to perform this type of
20 analysis and for which there exists no conflict of interest in the
21 analysis being provided. The analysis may be waived by the council for
22 any retirement system with assets of less than one million dollars.

24 ~~year beginning in 2020,~~ the council shall prepare a written plan of
25 action and shall present such plan to the Nebraska Retirement Systems
26 Committee of the Legislature at a public hearing. The plan shall include,
27 but not be limited to, the council's investment portfolios, investment
28 strategies, the duties and limitations of the state investment officer,
29 and an organizational structure of the council's office.

30 Sec. 5. Section 79-902, Revised Statutes Supplement, 2021, is
31 amended to read:

1 79-902 For purposes of the School Employees Retirement Act, unless
2 the context otherwise requires:

3 (1) Accumulated contributions means the sum of all amounts deducted
4 from the compensation of a member and credited to his or her individual
5 account in the School Retirement Fund together with regular interest
6 thereon, compounded monthly, quarterly, semiannually, or annually;

7 (2)(a) Actuarial equivalent means the equality in value of the
8 aggregate amounts expected to be received under different forms of
9 payment.

10 (b) For a school employee hired before July 1, 2017, the
11 determinations shall be based on the 1994 Group Annuity Mortality Table
12 reflecting sex-distinct factors blended using twenty-five percent of the
13 male table and seventy-five percent of the female table. An interest rate
14 of eight percent per annum shall be reflected in making these
15 determinations except when a lump-sum settlement is made to an estate.

16 (c) For a school employee hired on or after July 1, 2017, or rehired
17 on or after July 1, 2017, after termination of employment and being paid
18 a retirement benefit or taking a refund of contributions, the
19 determinations shall be based on a unisex mortality table and an interest
20 rate specified by the board. Both the mortality table and the interest
21 rate shall be recommended by the actuary and approved by the retirement
22 board following an actuarial experience study, a benefit adequacy study,
23 or a plan valuation. The mortality table, interest rate, and actuarial
24 factors in effect on the school employee's retirement date will be used
25 to calculate actuarial equivalency of any retirement benefit. Such
26 interest rate may be, but is not required to be, equal to the assumed
27 rate.

28 (d) If the lump-sum settlement is made to an estate, the interest
29 rate will be determined by the AAA-rated segment of the Bloomberg
30 Barclays Long U.S. Corporate Bond Index as of the prior June 30, rounded
31 to the next lower quarter percent. If the AAA-rated segment of the

1 Bloomberg Barclays Long U.S. Corporate Bond Index is discontinued or
2 replaced, a substitute index shall be selected by the board which shall
3 be a reasonably representative index;

4 (3) Beneficiary means any person in receipt of a school retirement
5 allowance or other benefit provided by the act;

6 (4)(a) Compensation means gross wages or salaries payable to the
7 member for personal services performed during the plan year and includes
8 (i) overtime pay, (ii) member retirement contributions, (iii) retroactive
9 salary payments paid pursuant to court order, arbitration, or litigation
10 and grievance settlements, and (iv) amounts contributed by the member to
11 plans under sections 125, 403(b), and 457 of the Internal Revenue Code as
12 defined in section 49-801.01 or any other section of the code which
13 defers or excludes such amounts from income.

14 (b) Compensation does not include (i) fraudulently obtained amounts
15 as determined by the retirement board, (ii) amounts for accrued unused
16 sick leave or accrued unused vacation leave converted to cash payments,
17 (iii) insurance premiums converted into cash payments, (iv) reimbursement
18 for expenses incurred, (v) fringe benefits, (vi) per diems paid as
19 expenses, (vii) bonuses for services not actually rendered, (viii) early
20 retirement inducements, (ix) cash awards, (x) severance pay, or (xi)
21 employer contributions made for the purposes of separation payments made
22 at retirement.

23 (c) Compensation in excess of the limitations set forth in section
24 401(a)(17) of the Internal Revenue Code as defined in section 49-801.01
25 shall be disregarded. For an employee who was a member of the retirement
26 system before the first plan year beginning after December 31, 1995, the
27 limitation on compensation shall not be less than the amount which was
28 allowed to be taken into account under the retirement system as in effect
29 on July 1, 1993;

30 (5) County school official means (a) until July 1, 2000, the county
31 superintendent or district superintendent and any person serving in his

1 or her office who is required by law to have a teacher's certificate and
2 (b) on or after July 1, 2000, the county superintendent, county school
3 administrator, or district superintendent and any person serving in his
4 or her office who is required by law to have a teacher's certificate;

5 (6)(a) Creditable service means prior service for which credit is
6 granted under sections 79-926 to 79-929, service credit purchased under
7 sections 79-933.03 to 79-933.06 and 79-933.08, and all service rendered
8 while a contributing member of the retirement system; and

9 (b) Creditable service includes working days, sick days, vacation
10 days, holidays, and any other leave days for which the employee is paid
11 regular wages as part of the employee's agreement with the employer.
12 Creditable service does not include lump-sum payments to the employee
13 upon termination or retirement in lieu of accrued benefits for such days,
14 eligibility and vesting credit, service years for which member
15 contributions are withdrawn and not repaid by the member, service
16 rendered for which the retirement board determines that the member was
17 paid less in compensation than the minimum wage as provided in the Wage
18 and Hour Act, service which the board determines was rendered with the
19 intent to defraud the retirement system, or service provided to an
20 employer in a retirement system established pursuant to the Class V
21 School Employees Retirement Act;

22 (7) Current benefit means the initial benefit increased by all
23 adjustments made pursuant to the School Employees Retirement Act;

24 (8) Disability means an inability to engage in any substantially
25 gainful activity by reason of any medically determinable physical or
26 mental impairment which was initially diagnosed or became disabling while
27 the member was an active participant in the plan and which can be
28 expected to result in death or be of a long-continued and indefinite
29 duration;

30 (9) Disability retirement allowance means the annuity paid to a
31 person upon retirement for disability under section 79-952;

1 (10) Disability retirement date means the first day of the month
2 following the date upon which a member's request for disability
3 retirement is received on a retirement application provided by the
4 retirement system if the member has terminated employment in the school
5 system and has complied with sections 79-951 to 79-954 as such sections
6 refer to disability retirement;

7 (11) Early retirement inducement means, but is not limited to:

8 (a) A benefit, bonus, or payment to a member in exchange for an
9 agreement by the member to terminate from employment;

10 (b) A benefit, bonus, or payment paid to a member in addition to the
11 member's retirement benefit;

12 (c) Lump-sum or installment cash payments, except payments for
13 accrued unused leave converted to cash payments;

14 (d) An additional salary or wage component of any kind that is being
15 paid as an incentive to leave employment and not for personal services
16 performed for which creditable service is granted;

17 (e) Partial or full employer payment of a member's health, dental,
18 life, or long-term disability insurance benefits or cash in lieu of such
19 insurance benefits that extend beyond the member's termination of
20 employment and contract of employment dates. This subdivision does not
21 apply to any period during which the member is contributing to the
22 retirement system and being awarded creditable service; and

23 (f) Any other form of separation payments made by an employer to a
24 member at termination, including, but not limited to, purchasing
25 retirement annuity contracts for the member pursuant to section 79-514,
26 depositing money for the member in an account established under section
27 403(b) of the Internal Revenue Code except for payments for accrued
28 unused leave, or purchasing service credit for the member pursuant to
29 section 79-933.08;

30 (12) Eligibility and vesting credit means credit for years, or a
31 fraction of a year, of participation in a Nebraska government plan for

1 purposes of determining eligibility for benefits under the School
2 Employees Retirement Act. Such credit shall not be included as years of
3 creditable service in the benefit calculation;

4 (13) Emeritus member means a person (a) who has entered retirement
5 under ~~the provisions of~~ the act, including those persons who have retired
6 since July 1, 1945, under any other regularly established retirement or
7 pension system as contemplated by section 79-916, (b) who has thereafter
8 been reemployed in any capacity by a public school, a Class V school
9 district, or a school under the control and management of the Board of
10 Trustees of the Nebraska State Colleges, the Board of Regents of the
11 University of Nebraska, or a community college board of governors or has
12 become a state school official or county school official subsequent to
13 such retirement, and (c) who has applied to the board for emeritus
14 membership in the retirement system. The school district or agency shall
15 certify to the retirement board on forms prescribed by the retirement
16 board that the annuitant was reemployed, rendered a service, and was paid
17 by the district or agency for such services;

18 (14) Employer means the State of Nebraska or any subdivision thereof
19 or agency of the state or subdivision authorized by law to hire school
20 employees or to pay their compensation;

21 (15)(a) Final average compensation means:

22 (i) Except as provided in subdivision (ii) of this subdivision:

23 (A) The sum of the member's total compensation during the three
24 twelve-month periods of service as a school employee in which such
25 compensation was the greatest divided by thirty-six; or

26 (B) If a member has such compensation for less than thirty-six
27 months, the sum of the member's total compensation in all months divided
28 by the total number of months of his or her creditable service therefor;
29 and

30 (ii) For an employee who became a member on or after July 1, 2013:

31 (A) The sum of the member's total compensation during the five

1 twelve-month periods of service as a school employee in which such
2 compensation was the greatest divided by sixty; or

3 (B) If a member has such compensation for less than sixty months,
4 the sum of the member's total compensation in all months divided by the
5 total number of months of his or her creditable service therefor.

6 (b) Payments under the Retirement Incentive Plan pursuant to section
7 79-855 and Staff Development Assistance pursuant to section 79-856 shall
8 not be included in the determination of final average compensation;

9 (16) Fiscal year means any year beginning July 1 and ending June 30
10 next following;

11 (17) Hire date or date of hire means the first day of compensated
12 service subject to retirement contributions;

13 (18) Initial benefit means the retirement benefit calculated at the
14 time of retirement;

15 (19) Member means any person who has an account in the School
16 Retirement Fund;

17 (20) Participation means qualifying for and making required deposits
18 to the retirement system during the course of a plan year;

19 (21) Plan year means the twelve-month period beginning on July 1 and
20 ending on June 30 of the following year;

21 (22) Prior service means service rendered as a school employee in
22 the public schools of the State of Nebraska prior to July 1, 1945;

23 (23) Public school means any and all schools offering instruction in
24 elementary or high school grades, as defined in section 79-101, which
25 schools are supported by public funds and are wholly under the control
26 and management of the State of Nebraska or any subdivision thereof,
27 including (a) schools or other entities established, maintained, and
28 controlled by the school boards of local school districts, except Class V
29 school districts, (b) any educational service unit, and (c) any other
30 educational institution wholly supported by public funds, except schools
31 under the control and management of the Board of Trustees of the Nebraska

1 State Colleges, the Board of Regents of the University of Nebraska, or
2 the community college boards of governors for any community college
3 areas;

4 (24) Regular employee means an employee hired by a public school or
5 under contract in a regular full-time or part-time position who works a
6 full-time or part-time schedule on an ongoing basis for twenty or more
7 hours per week. An employee hired as described in this subdivision to
8 provide service for less than twenty hours per week but who provides
9 service for an average of twenty hours or more per week in each calendar
10 month of any three calendar months of a plan year shall, beginning with
11 the next full payroll period, commence contributions and shall be deemed
12 a regular employee for all future employment with the same employer;

13 (25) Regular interest means interest fixed at a rate equal to the
14 daily treasury yield curve for one-year treasury securities, as published
15 by the Secretary of the Treasury of the United States, that applies on
16 July 1 of each year, which may be credited monthly, quarterly,
17 semiannually, or annually as the board may direct;

18 (26) Relinquished creditable service means, with respect to a member
19 who has withdrawn his or her accumulated contributions under section
20 79-955, the total amount of creditable service which such member has
21 given up as a result of his or her election not to remain a member of the
22 retirement system;

23 (27) Required beginning date means, for purposes of the deferral of
24 distributions, April 1 of the year following the calendar year in which a
25 member has:

26 (a)(i) Terminated employment with all employers participating in the
27 plan; and

28 (ii)(A) Attained at least seventy and one-half years of age for a
29 member who attained seventy and one-half years of age on or before
30 December 31, 2019; or

31 (B) Attained at least seventy-two years of age for a member who

1 attained seventy and one-half years of age on or after January 1, 2020;
2 or

3 (b)(i) Terminated employment with all employers participating in the
4 plan; and

5 (ii) Otherwise reached the date specified by section 401(a)(9) of
6 the Internal Revenue Code and the regulations issued thereunder;

7 (28) Required deposit means the deduction from a member's
8 compensation as provided for in section 79-958 which shall be deposited
9 in the School Retirement Fund;

10 (29) Retirement means qualifying for and accepting a school or
11 disability retirement allowance granted under the School Employees
12 Retirement Act;

13 (30) Retirement application means the form approved and provided by
14 the retirement system for acceptance of a member's request for either
15 regular or disability retirement;

16 (31) Retirement board or board means the Public Employees Retirement
17 Board;

18 (32) Retirement date means (a) if the member has terminated
19 employment, the first day of the month following the date upon which a
20 member's request for retirement is received on a retirement application
21 provided by the retirement system or (b) if the member has filed a
22 retirement application but has not yet terminated employment, the first
23 day of the month following the date on which the member terminates
24 employment. An application may be filed no more than one hundred twenty
25 days prior to the effective date of the member's initial benefit;

26 (33) Retirement system means the School Employees Retirement System
27 of the State of Nebraska;

28 (34) Savings annuity means payments for life, made in equal monthly
