1 A BILL FOR AN ACT relating to personal care services; to amend sections
2 71-6501 and 71-6602, Reissue Revised Statutes of Nebraska; to
3 include bathing as an activity of daily living; to redefine terms;
4 and to repeal the original sections.

5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 71-6501, Reissue Revised Statutes of Nebraska, is
2 amended to read:

3 71-6501 For purposes of sections 71-6501 to 71-6504:

4 (1) Activities of daily living has the definition found in section
5 71-6602;

6 (2) Attendant services means services provided to nonmedically
7 fragile persons, including hands-on assistance with activities of daily
8 living, transfer, grooming, bathing, medication reminders, and similar
9 activities;

10 (3) Companion services means the provision of companionship and
11 assistance with letter writing, reading, and similar activities;

12 (4) Homemaker services means assistance with household tasks,
13 including, but not limited to, housekeeping, personal laundry, shopping,
14 incidental transportation, and meals;

15 (5) In-home personal services means attendant services, companion
16 services, and homemaker services that do not require the exercise of
17 medical or nursing judgment provided to a person in his or her residence
18 to enable the person to remain safe and comfortable in such residence;

19 (6) In-home personal services agency means an entity that provides
20 or offers to provide in-home personal services for compensation by
21 employees of the agency or by persons with whom the agency has contracted
22 to provide such services. In-home personal services agency does not
23 include a local public health department as defined in section 71-1626, a
24 health care facility as defined in section 71-413, a health care service
25 as defined in section 71-415, programs supported by the federal
26 Corporation for National and Community Service, an unlicensed home care
27 registry or similar entity that screens and schedules independent
28 contractors as caregivers for persons, or an agency that provides only
29 housecleaning services. A home health agency may be an in-home personal
30 services agency; and

31 (7) In-home personal services worker means a person who meets the

1 requirements of section 71-6502 and provides in-home personal services.

2 Sec. 2. Section 71-6602, Reissue Revised Statutes of Nebraska, is
3 amended to read:

4 71-6602 As used in sections 71-6601 to 71-6615, unless the context
5 otherwise requires:

6 (1) Activities of daily living means assistance with ambulation,
7 bathing, toileting, feeding, and similar activities;

8 (2) Basic therapeutic care means basic health care procedures,
9 including, but not limited to, measuring vital signs, applying hot and
10 cold applications and nonsterile dressings, and assisting with, but not
11 administering, internal and external medications which are normally self-
12 administered. Basic therapeutic care does not include health care
13 procedures which require the exercise of nursing or medical judgment;

14 (3) Department means the Department of Health and Human Services;

15 (4) Home health agency means a home health agency as defined in
16 section 71-417;

17 (5) Home health aide means a person who is employed by a home health
18 agency to provide personal care, assistance with the activities of daily
19 living, and basic therapeutic care to patients of the home health agency;

20 (6) Personal care means ~~bathing,~~ hair care, nail care, shaving,
21 dressing, oral care, and similar activities;

22 (7) Supervised practical training means training in a laboratory or
23 other setting in which the trainee demonstrates knowledge while
24 performing tasks on an individual under the direct supervision of a
25 registered nurse or licensed practical nurse; and

26 (8) Vital signs means temperature, pulse, respiration, and blood
27 pressure.
