**LEGISLATIVE BILL 1106**

Introduced by Day, 49.

Read first time January 19, 2022

- 1 A BILL FOR AN ACT relating to relating to the Mental Health Practice Act;
- 2 to amend sections 38-2122 and 38-2123, Revised Statutes Cumulative
- 3 Supplement, 2020; to change licensure qualifications for provisional
- 4 mental health practitioners and mental health practitioners; to
- 5 harmonize provisions; and to repeal the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 38-2122, Revised Statutes Cumulative Supplement,  
2 2020, is amended to read:

3 38-2122 A person shall be qualified to be a licensed mental health  
4 practitioner if he or she:

5 (1)(a) ~~(1)~~ Has received a master's degree, a doctoral degree, or the  
6 equivalent of a master's degree, as determined by the board, that  
7 consists of course work and training which was primarily therapeutic  
8 mental health in content and included a practicum or internship and was  
9 from an approved educational program. Practicums or internships completed  
10 after September 1, 1995, must include a minimum of three hundred clock  
11 hours of direct client contact under the supervision of a qualified  
12 physician, a licensed psychologist, or a licensed mental health  
13 practitioner; or

14 (b) Has a master's degree, an educational specialist degree, a  
15 doctoral degree, or the equivalent of a master's degree, as determined by  
16 the board, that consists of course work and training which was primarily  
17 therapeutic mental health in content and included a practicum or  
18 internship and was from an educational program approved or accredited by  
19 the National Association of School Psychologists;

20 (2) Has successfully completed three thousand hours of supervised  
21 experience in mental health practice of which fifteen hundred hours were  
22 in direct client contact in a setting where mental health services were  
23 being offered and the remaining fifteen hundred hours included, but were  
24 not limited to, review of client records, case conferences, direct  
25 observation, and video observation. For purposes of this subdivision,  
26 supervised means monitored by a qualified physician, a licensed clinical  
27 psychologist, or a certified master social worker, certified professional  
28 counselor, or marriage and family therapist qualified for certification  
29 on September 1, 1994, for any hours completed before such date or by a  
30 qualified physician, a psychologist licensed to engage in the practice of  
31 psychology, or a licensed mental health practitioner for any hours

1 completed after such date, including evaluative face-to-face contact for  
2 a minimum of one hour per week. Such three thousand hours shall be  
3 accumulated after completion of the master's degree, doctoral degree, or  
4 equivalent of the master's degree; and

5 (3) Has satisfactorily passed an examination approved by the board  
6 which shall include the option of a board-approved examination from the  
7 National Association of School Psychologists. An individual who by reason  
8 of educational background is eligible for certification as a certified  
9 master social worker, a certified professional counselor, ~~or~~ a certified  
10 marriage and family therapist, or a nationally certified school  
11 psychologist shall take and pass a certification examination approved by  
12 the board before becoming licensed as a mental health practitioner.

13 Sec. 2. Section 38-2123, Revised Statutes Cumulative Supplement,  
14 2020, is amended to read:

15 38-2123 (1) A person who needs to obtain the required three thousand  
16 hours of supervised experience in mental health practice as specified in  
17 section 38-2122 to qualify for a mental health practitioner license shall  
18 obtain a provisional mental health practitioner license. To qualify for a  
19 provisional mental health practitioner license, such person shall:

20 (a)(i) (a) Have a master's degree, a doctoral degree, or the  
21 equivalent of a master's degree, as determined by the board, that  
22 consists of course work and training which was primarily therapeutic  
23 mental health in content and included a practicum or internship and was  
24 from a mental health program as specified in section 38-2122; or

25 (ii) Have a master's degree, an educational specialist degree, a  
26 doctoral degree, or the equivalent of a master's degree, as determined by  
27 the board, that consists of course work and training which was primarily  
28 therapeutic mental health in content and included a practicum or  
29 internship and was from an educational program approved or accredited by  
30 the National Association of School Psychologists;

31 (b) Apply prior to earning the three thousand hours of supervised

1 experience; and

2 (c) Pay the provisional mental health practitioner license fee.

3 (2) The rules and regulations approved by the board and adopted and  
4 promulgated by the department shall not require that the applicant have a  
5 supervisor in place at the time of application for a provisional mental  
6 health practitioner license.

7 (3) A provisional mental health practitioner license shall expire  
8 upon receipt of licensure as a mental health practitioner or five years  
9 after the date of issuance, whichever comes first.

10 (4) A person who holds a provisional mental health practitioner  
11 license shall inform all clients that he or she holds a provisional  
12 license and is practicing mental health under supervision and shall  
13 identify the supervisor. Failure to make such disclosure is a ground for  
14 discipline as set forth in section 38-2139.
