- 1 A BILL FOR AN ACT relating to elections; to amend section 32-943, Reissue
- 2 Revised Statutes of Nebraska; to provide for return of a marked
- 3 ballot for early voting by a voter-appointed agent; to change an
- 4 agent restriction; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 32-943, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 32-943 (1) Any registered voter who is permitted to vote early
- 4 pursuant to section 32-938 may appoint an agent to (a) submit a request
- 5 for a ballot for early voting on his or her behalf of such voter or (b)
- 6 return a marked ballot to the election commissioner or county clerk on
- 7 behalf of such voter. The registered voter or his or her agent may
- 8 request that the ballot be sent to the registered voter by mail or
- 9 indicate on the request that the agent will personally pick up the ballot
- 10 for such registered voter from the office of the election commissioner or
- 11 county clerk. A registered voter or an agent acting on behalf of a
- 12 registered voter shall request a ballot in writing to the election
- 13 commissioner or county clerk in the county where the registered voter has
- 14 established his or her residence and shall indicate the voter's residence
- 15 address, the address to which the ballot is to be mailed if different,
- 16 and the voter's telephone number if available and precinct if known. The
- 17 registered voter or the voter's agent may use the form published by the
- 18 election commissioner or county clerk pursuant to section 32-808. The
- 19 registered voter or his or her agent shall sign the request.
- 20 (2) A candidate for office at such election and any person serving
- 21 on a campaign committee for such a candidate shall not act as an agent
- 22 for any registered voter requesting a ballot or returning a marked ballot
- 23 pursuant to this section unless such person is a member of the registered
- 24 voter's family. No person shall act as <u>an agent as described in either</u>
- 25 subdivision (1)(a) or (b) of this section for more than two registered
- 26 voters in any election.
- 27 (3) The agent shall pick up the ballot before one hour prior to the
- 28 closing of the polls on election day and deliver the ballot to the
- 29 registered voter. The ballot shall be returned not later than the closing
- 30 of the polls on the day of the election.
- 31 (4) The election commissioner or county clerk shall adopt procedures
