21 The unexpended General Fund appropriation balance existing on June
22 30, 2023, less \$5,000,000, is hereby reappropriated.

23 The budget division of the Department of Administrative Services
24 shall administratively transfer General Fund appropriations or Salary
25 Limits or both among Program Nos. 52, 67, 420, 434, 435, and 437 within
26 Agency 5, upon written certification by the State Court Administrator

1 that the Supreme Court has determined that such transfer is necessary for
2 the efficient functioning of statewide court operations and the proper
3 administration of justice.

4 There is included in the appropriation to this program for FY2023-24
5 \$270,000 General Funds and \$270,000 Cash Funds for dispute resolution
6 state aid, which shall only be used for such purpose. There is included
7 in the appropriation to this program for FY2024-25 \$270,000 General Funds
8 and \$270,000 Cash Funds for dispute resolution state aid, which shall
9 only be used for such purpose.

10 There is included in the appropriation to this program for FY2023-24
11 \$500,000 Cash Funds for parenting plan mediation for indigent and lower-
12 income persons involved in Parenting Act cases, as state aid, which shall
13 only be used for such purpose. There is included in the appropriation to
14 this program for FY2024-25 \$500,000 Cash Funds for parenting plan
15 mediation for indigent and lower-income persons involved in Parenting Act
16 cases, as state aid, which shall only be used for such purpose.

17 There is included in the appropriation to this program for FY2023-24
18 ~~\$600,000~~ ~~\$-0-~~ General Funds and for FY2024-25 ~~\$600,000~~ ~~\$-0-~~ General Funds
19 to increase the payments for interpreter services for deaf and hard of
20 hearing persons and for persons unable to communicate the English
21 language, which shall only be used for such purpose.

22 Cash Fund expenditures for this program shall not be limited to the
23 amounts shown.
