Dear Mr. Metzler:

As per State Statute 37-327.01 related to the Game Law Investigation Cash Fund, this letter shall serve as our Fiscal Year 2022-2023 annual report.

The Game Law Investigation Cash Fund (Fund 23360) was created as a result of the passage of LB 788 during the Ninety-Sixth Legislative Session, 2000. The fund is to be funded through revenue collected under the Game Law and budgeted or allocated to the fund by the commission, and through donations from persons, wildlife groups and other charitable sources.

The fund became officially established with the initial transfer of \$5,000 from the Game Cash Fund (Fund 23320) on July 27, 2000. Collection of fines totaling \$24,339.58 and \$2,758.26 of interest earnings increased the Fund during Fiscal Year 2022-2023. The June 30, 2023 cash balance was \$310,487.27.

The attached memo from Duane Arp, Law Enforcement Division Assistant Administrator, identifies the financial activity of the private sector accounts used for undercover field operations during Fiscal Year 2022-2023.

Included herewith is a copy of the rules pertaining to record-keeping procedures for the Game Law Investigation Cash Fund as approved in October of 2000. If you have questions, or I can provide any further information, please feel free to contact me.

As required in Nebraska State Statute 37-327.01 and Nebraska Game and Parks Commission regulation Title 163, Chapter 1, 011.01B2, I hereby report the following expenditures and interest for Fiscal Year 2022/2023 for the Game Law Investigation Cash Fund (GLICF). Table #1 contained in this report summarizes the activity in the GLICF account managed by the Law Enforcement Division of the Nebraska Game and Parks Commission for fiscal year 7/1/2022 through 6/30/2023. Subsdequent tables provide a more detailed breakdown of the income and expenses incurred during this reporting period.

The Law Enforcement Division of the Nebraska Game and Parks Commission currently maintains one active account holding GLICF funds in support of ongoing investigations as prescribed by state statutes. It should be noted that for the purposes of continuity, current account information on the one active account available will be referred to as Account #2. Previous accounts have been closed as related in previous reports. Note: previous reports indicated account held at First State Bank of Scottsbluff, NE. Riverstone Bank of Scottsbluff purchased First State Bank and our account has not changed.

## **Current Account Summaries**

Account #2 had a beginning balance as of July 1, 2022 of \$8272.44. Between July 1, 2022 and June 30, 2023, there was \$11.55 in accrued interest. Total expenditures for this time period were \$620.00. Itemized, these expenses were; covert expenditures of \$620.00. There were no salaries, front monies or informant payments made during this time period. There were three (3) withdrawls totaling \$620.00 to cover cash expenses with no cash monies left on hand. The current balance in the account as of July 1, 2023 is \$7,663.99.
