Cost Savings

During SFY 2024, OJS commitments remained similar to the 2023 consensus, while the average length of stay for youth decreased in all three facilities compared to the previous year. In total, OJS ended the year having expended 98.23% of the allotted budget. YRTCs do not possess any authority over juvenile commitments within the justice system and are unable to deny placement into the program. Juveniles are adjudicated through the courts, and if committed to OJS, must enter the program. OJS makes continuous efforts to be cost effective and increase successful rehabilitation through advocating for all youth committed regarding services, placements, and evaluations.
