

a. All Children

Percentage by Service Area


Data includes youth with the following legal statuses: Office of Juvenile Services and Health and Human Services state wards; court supervision youth; youth who have been directly relinquished to the state as Health and Human Services state wards or Office of Juvenile Services ward; non-court involved youth; youth in a police hold; youth in placement with the Department and alternative response youth and families. Data extracted is from the Children and Family Services' (CFS) N-FOCUS system. Number of children served is an unduplicated count. Eastern CFS cases include alternative response youth served in Douglas and Sarpy Counties. Alternative response cases are case managed by CFS staff.



b. State Wards


Percentage by Service Area

b. Number of Children Receiving Behavioral Health Services at the Hastings Regional Center

The Division of Behavioral Health no longer serves children at the Hastings Regional Center and did not serve children there during SFY 2023.

c. Number of State Wards Receiving Behavioral Health Service as of September 1, 2023

Division of Behavioral Health: Youth Served Who Were Wards of the State = 25. Data from the CFS N-FOCUS system shows 169 state wards received behavioral health services paid for by the Division of Children Family Services during SFY 23. Data also shows 5,320 state wards received behavioral services paid for by Nebraska Medicaid through the DHHS Medicaid and Long-Term Care Division.

d. FY23 Funding Sources for Children's Behavioral Health Services

Children's behavioral health services during Fiscal Year 2023 were funded by state General Funds, the Community Mental Health Services Block Grant, and the Substance Abuse Prevention and Treatment Block Grant.

e. FY23 Expenditures by Category of Behavioral Health Service and by Behavioral Health Region

Data provided for state fiscal year 2023 (July 2022 – June 2023). Six Behavioral Health Regions in Nebraska. For the purposes of this report, a service is the type of work performed and the Service Category is a Child's service. Expenditures are the total dollars paid in SFY 2023. Payments pending or in-process are not included. Data extracted is from the DHHS Division of Behavioral Health. 


b. Caseload per Case Manager



This data includes the average number of CFSS per child's case for children who have been in the child welfare system for three, six, twelve, and eighteen months and the consecutive yearly average for children until the age of majority or permanency is attained.

For the Eastern Service Area, the case manager count includes DHHS case managers who conduct initial assessments and contracted agency staff who provided ongoing case management. Data after June 2022 does not include contracted agency staff.





Chart 1 for f.: Statewide Percentage of Monthly Visits with Parent, Child, and Provider















i. Monthly Consecutive Child Contacts with Case Manager






Wards in Residential Treatment Settings by Service Area


Wards in Residential Treatment Settings by Age


Wards in Residential Treatment Settings by Gender




Wards in Residential Treatment Settings by Race/Ethnicity






