Electronic Visit Verification (EVV)

Nebraska's Department of Health and Human Services (DHHS) continues to work successfully with Netsmart (the state's EVV vendor). As a result, adoption continues to trend upward. Please see the latest EVV statistics for 2023:

In a letter dated July 27, 2022, the Centers for Medicare and Medicaid Services (CMS) notified DHHS that the EVV module was certified. CMS approved the State's request for certification retroactive to the December 13, 2020, implementation date. As a result, DHHS has been approved for 75 percent Federal Financial Participation (FFP) retroactive to the first day in the calendar quarter following the project implementation date. DHHS provides quarterly performance reporting to CMS in support of ongoing funding.
