



**NOTICE REQUIRED PURSUANT TO
SECTION 58-270(3) OF THE
NEBRASKA INVESTMENT FINANCE AUTHORITY ACT**

the issuance of Bonds)

The Nebraska Investment Finance Authority (the “Authority”) hereby gives notice in accordance with the Nebraska Investment Finance Authority Act, Sections 58-201 et seq., Reissue Revised Statutes of Nebraska, as amended (the “Act”), to Jim Pillen, Governor of the State of Nebraska (the “State”), and Brandon Metzler, Clerk of the State Legislature, following the issuance by the Authority of the following bonds (collectively, the “2024 Series G/H Bonds”):

2024 Series H (Taxable)

The 2024 Series G/H Bonds were issued by the Authority on November 26, 2024 pursuant to a General Indenture of Trust, dated as of July 1, 1994 (as amended, the “General Indenture”), and the Supplemental Indenture of Trust, dated as of November 1, 2024 (the “Supplemental Indenture” and including the General Indenture, the “Indenture”), each between the Authority and Computershare Trust Company, National Association, as trustee (the “Trustee”). This Notice is being filed with the Governor of the State and the Clerk of the State Legislature within 30 days following the issuance of the 2024 Series G/H Bonds. A “Notice Required Pursuant to Section 58-270, Reissue Revised Statutes of Nebraska” was previously filed with the Governor of the State and the Clerk of the State Legislature on October 27, 2023 and August 23, 2024 respectively. Capitalized terms not otherwise defined herein shall have the respective meanings assigned to them in the Indenture.

You are hereby notified of the following:

- (a) *Principal Amount.* Final principal amount of the 2024 Series G/H Bonds: \$130,955,000.00
- (b) *Net Interest Cost of the Bonds.* Net interest cost of the 2024 Series G/H Bonds: 5.058722943%

(d) *Mortgage Loan Fund.* Proceeds of the 2024 Series G/H Bonds in the amount of (i) \$99,996,499.00 (representing the principal amount of the 2024 Series G Bonds (\$95,955,000.00), together with premium thereon in the amount of \$4,041,499.00) were deposited in the 2024 Series G Mortgage Loan Fund Account (First Home) of the Mortgage Loan Fund and (ii) \$55,000,000.00 (representing the principal amount of the 2024 Series H Bonds (\$35,000,000.00, plus funds available under the General Indenture in the amount of \$20,000,000.00), were deposited in the 2024 Series H Mortgage Loan Fund Account (Welcome Home) of the Mortgage Loan Fund and are expected to be used to acquire, purchase and finance Mortgage-Backed Securities (backed by qualifying Mortgage Loans) and related second mortgages.

(e) *Redemption Fund.* No deposit was made to the Redemption Fund upon issuance of the Bonds.

- (f) *Debt Service Reserve Fund.* No deposit was made to the Debt Service Reserve Fund upon issuance of the Bonds.
- (g) *Mortgage Reserve Fund.* No deposit was made to the Mortgage Reserve Fund upon issuance of the Bonds.
- (h) *Issuance Expense Account.* Indenture funds in the amount of \$1,200,161.00 (out of which the Underwriters at closing shall be paid fees and reimbursed expenses equal to (i) \$644,189.07 attributable to the purchase of the 2024 Series G Bonds and (ii) \$155,971.93 attributable to the purchase of the 2024 Series H Bonds) are being used to pay the costs of issuing the 2024 Series G/H Bonds. Any remaining balance therein will be transferred to the Revenue Fund or the Mortgage Loan Fund as directed by NIFA.
- (i) *Available Funds.* The amount of funds available from the proceeds of the 2024 Series G/H Bonds for financing new Mortgage Loans and Mortgage-Backed Securities backed by qualifying Mortgage Loans and related second mortgages is equal to \$134,996,499.00.
- (j) *Blended Net Interest (Mortgages).* The blended average net interest cost to the beneficiaries or borrowers is not expected to exceed:
 - (i) Mortgage interest rates:
 - 2024 Series G (First Home)
 - (A) 5.308% for Series 2024 Series G GNMA Mortgage Loans
 - (B) 5.797% for Series 2024 Series G FNMA/FHLMC Mortgage Loans
 - (C) 2.000% for Series 2024 Series G Community Program Loans
 - 2024 Series H (Welcome Home)
 - (A) 6.090% for Series 2024 Series H GNMA Mortgage Loans
 - (B) 6.460% for Series 2024 Series H FNMA/FHLMC Mortgage Loans
 - (C) 2.000% for Series 2024 Series H Community Program Loans
