The Lancaster County Youth Services Center reports all instances of room confinement that total to over 1 hour in a 24-hour period. For example, if a youth is placed in their room for a time out for 30 minutes, in their room for our safety check for 45 minutes, then there are 2 instances for the day that total over 1 hour.

There were 38 unique juveniles with room confinement time totally 1132.68 hours.

 - 282.90 for the safety of the juvenile or others in the immediate area (physical assaults on peers and staff, gang activity, attempted assaults, verbal aggression)
