LB1033 changes the use of a handheld wireless communication device while operating a motor vehicle in motion, from a secondary offense to a primary offense.

There would be no fiscal impact to neither the Nebraska Department of Motor Vehicles, nor the Nebraska State Patrol. A political subdivision the Lancaster County Sheriff's Office responded with a likely increase in expenses due to a possible rise in the number of traffic stops if this bill were to pass.
