Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 1294 is the Data Privacy Act.

Section 2 provides definitions for the Act. Sections 3 and 4 identify persons who to whom the Act does and doesn't apply.

Under provisions of the Act, a consumer may submit a request to a controller specifying the consumer rights the consumer wishes to exercise. Parents or legal guardians may exercise the consumer rights on behalf of a child. Controllers shall establish a process for a consumer to appeal the controller's refusal to take action on a request. In addition, controllers shall establish two or more secure and reliable methods to enable a consumer to submit a request to exercise consumer rights under the Act.

Section 12 establishes limitations and prohibitions for controllers. For example, a controller shall limit the collection of personal data to what is adequate, relevant, and reasonably necessary in relation to the purpose for which personal data is processed. If a controller sells personal data to any third party or processes personal data for targeted advertising, the controller shall clearly and conspicuously disclose that process and the manner in which a consumer may opt out of that process.

The Attorney General is charged with exclusive authority to enforce the Act and shall post certain information on their website. Violators of the Act are subject to a civil penalty in an amount not to exceed \$7,500 per violation.

The Attorney General and the Department of Health and Human Services estimate no fiscal impact.
