LB136 deals with allowing ATV/UTV owners to file for certificates of title in any Nebraska county, not just the county of residence. Second, LB136 adds violations of the International Registration Plan Act to the list of reasons the director of the DMV may suspend, revoke, cancel, or refuse to issue or renew a registration certificate. Finally, LB136 changes the length of validity time and seasonal period length for the restricted commercial driver's licenses.

The Nebraska Department of Motor Vehicles had indicated there would be no fiscal impact.

There is no basis to disagree with this estimate.
